A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO PURSUE THE NATIONAL URBAN AND COMMUNITY FORESTRY GRANT PROGRAM; AUTHORIZING UP TO \$50,000.00 IN MATCHING FUNDS FOR THE GRANT; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") recognizes the importance and the benefits that trees provide to our community; and

WHEREAS, the City wishes to pursue grant funds to enhance our urban tree canopy, by conducting a citywide tree canopy inventory and developing an Urban Tree Management Plan; and

WHEREAS, City Staff has recommended that the City Council approve budgeting matching funds up to \$50,000 for FY 2017-18, if grant funding is awarded to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 3. Authorization. The City Manager is authorized to apply for the grant funding and budget \$50,000 in matching funds under the Public Works Department FY 2017-18 General Fund if the City is awarded the grant funding.
