

**RESOLUTION No. 21-84**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE AWARD OF FISCAL YEAR 2021 CYCLE COMMUNITY BASED ORGANIZATION GRANTS IN THE AMOUNT OF \$4,650.00 TO DORAL CONTEMPORARY ART MUSEUM; \$4,750.00 TO EVERLASTING DANCE FOUNDATION; \$4,900.00 TO MIAMI YOUTH SYMPHONY; AND \$4,500.00 TO POWER2VOICE CORP.; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral received four (4) applications by eligible organizations in response to the FY21 Cycle of Community Based Organization (CBO) Grant Applications by March 19th, 2021; and

**WHEREAS**, after careful review of the applications, the CBO Scoring Committee respectfully recommends that the Mayor and City Council approve CBO awards to each of the following organizations:

1. Doral Contemporary Art Museum - \$4,650.00
2. Everlasting Dance Foundation - \$4,750.00
3. Miami Youth Symphony - \$4,900.00
4. Power2Voice Corp. - \$4,500.00

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.
