

**RESOLUTION No. 21-226**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY KLANDESTINO RUNNERS AND LEON TO HOST THE 7 KLANDESTINO RACE TO BE HELD AT DORAL MEADOW PARK, LOCATED AT 11555 NW 58 STREET, DORAL, FL 33178 ON SUNDAY, DECEMBER 19, 2021, FROM 6:00 AM TO 12:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Eduardo Orozco on behalf of Klandestino Runners and Leon (the “Applicant”) seeks approval from the City of Doral for a Special Event Permit to host the “7 Klandestino” race; and

**WHEREAS**, staff recommends that the Mayor & City Council approve the proposed Outdoor Event Permit to host the “7 Klandestino” race Sunday, December 19, 2021 at Doral Meadow Park, located at 11555 NW 58 Street, Doral, FL 33178, from 6:00 a.m. to 12:00 p.m.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The special event permit for the “7 Klandestino” race is hereby approved subject to the following conditions:

1. Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees.
2. Applicant shall obtain all required permits.
3. Applicant shall be required to have all inspections and approvals prior to the event date.

4. Applicant shall provide to the City of Doral an acceptable certificate of insurance four weeks prior to the event date.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.
