A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE DORAL SOCCER CLUB, INC. AND CRISTI'S DANCE STUDIO AS PREQUALIFIED VENDORS FOR THE PROVISION OF SPECIALTY CAMP SERVICES FOR A PERIOD OF ONE (1) YEAR WITH AN OPTION OF TWO (2), ONE (1)-YEAR RENEWALS; AUTHORIZING THE CITY MANGER TO NEGOTIATE AND ENTER INTO FUTURE AGREEMENTS WITH THE DORAL SOCCER CLUB, INC. AND CRISTI'S DANCE STUDIO AS CITY OF DORAL PRE-QUALIFIED VENDORS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The City of Doral offers a variety of recreational opportunities to its residents through its Parks and Recreation Department; and

WHEREAS, In response to RFQ #2009-02 titled "Specialty Camp Services for Soccer & Dance," the City of Doral received two (2) and, after review by the selection committee, it was determined that the two (2) received, The Doral Soccer Club, Inc. and Cristi's Dance Studio, met the requirements of the RFQ; and

WHEREAS, Staff respectfully requests that the City Council approve The Doral Soccer Club, Inc. and Cristi's Dance Studio as pre-qualified vendors for the provision of specialty camp services for a period of one (1) year with an option of two (2), one (1)-year renewals; and

WHEREAS, Staff additionally requests that the City Council authorize the City Manager to negotiate and enter into future agreements with The Doral Soccer Club, Inc. and Cristi's Dance Studio as City of Doral pre-qualified vendors.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL AS FOLLOWS:
