IN AN AMOUNT NOT TO EXCEED \$46,738.44 AS THE TOP RANKED VENDOR; SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PROVISION OF NETWORK INFRASTRUCTURE HARDWARE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, On May 12, 2016, ITB #2016-12, "CommScope & GE Power Components for the Network Infrastructure at Legacy Park" was advertised for the provision of network infrastructure hardware; and

WHEREAS, One (1) proposal submittals were received on May 31, 2016; and WHEREAS, Staff has recommended the approval to award ITB #2016-12, "CommScope & GE Power Components for the Network Infrastructure at Legacy Park" to the top ranked firm and authorize the City Manager to negotiate and enter into an agreement with Tessco Inc. in an amount not to exceed \$46,738.44 for network infrastructure hardware.

The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interests of the City. This Authorization does not create or confer any rights to Tessco Inc.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.
