You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 5, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. This Work Order is not binding until the City of Doral agrees and approves this Work Order.

FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION (CEI) SERVICES FOR THE CONSTRUCTION OF NEW TRAFFIC SIGNALS ALONG NW 74 STREET AT NW 97 AVENUE AND NW 102 AVENUE, IN AN AMOUNT NOT TO EXCEED \$95,264.80; RECOGNIZING THAT BCC ENGINEERING, INC. IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Public Works Department (PWD) wishes to secure a firm to provide Construction Engineering Inspection (CEI) services for the construction of two new traffic signals along NW 74 Street at NW 97 Avenue and NW 102 Avenue; and

WHEREAS, BCC Engineering, Inc. (BCC) submitted a proposal to provide the CEI services as described in their proposal during the construction of the new traffic signals along NW 74 Street at NW 97 Avenue and NW 107 Avenue; and

WHEREAS, BCC is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, City staff respectfully requests that the Mayor and City Council members approve Work Order No. 9 for BCC, a copy of which is attached hereto as Exhibit "A", for the provision of CEI services for the construction of two new traffic signals along NW 74 Street at NW 97 Avenue and NW 102 Avenue in an amount not to exceed \$95,264.80.
