A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN EXPANSION OF THE SCOPE OF SERVICES FOR TOURFX IN THE TRI-PARTY AGREEMENT ASSOCIATED WITH THE ART KNIGHTS CONCERT TO INCLUDE VIDEO PRODUCTION SERVICES AND AN INCREASE IN THE FEE TO TOURFX IN THE AMOUNT OF \$22,000.00 FOR THE COST OF SAME; AUTHORIZING THE CITY MANAGER EXPEND FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in February of 2015, the City of Doral (the "City") was received the Knights Art Challenge Grant (the "Grant"), from the John and James L. Knight Foundation to promote cultural events; and

WHEREAS, in furtherance of the Grant, the City Council, via Resolution 15-194, approved a concert with world-renowned musical group, Forbidden Saints, as part of the City's "Art Knight at Downtown Doral Park" event series, to be held on January 23, 2016 (the "Concert"); and

WHEREAS, to produce the Concert, the City entered into the Event Production Tri-Party Agreement ("Tri-Party Agreement"), dated January 6, 2016, with Forbidden Saints, as the performer, and TourFX, as the production company; and

WHEREAS, the City has a previously-established, contractual relationship with TourFX for stage, sound, and lighting services for City events, as a result of being awarded Request for Production # 2015-17 Stage, Lighting, and Sound via City Council Resolution No. 15-112, and TourFX is willing and able to provide production services for the Event; and

WHEREAS, the Tri-Party Agreement contained a variety production services, including, but not limited to, lighting, staging and sound, but it did not provide for video recording; and

WHEREAS, prior to the event, the City concluded that recording the Concert would permit the showcasing of the event as a sign of the City's commitment to the performing arts, which could be shared locally, and perhaps even nationally; and

WHEREAS, though the Tri-Party Agreement permitted the City add the recording services to TourFX's scope of services, the City solicited quotes from three vendors; and

WHEREAS, TourFX offered the City the lowest price to perform video production services for the Concert; and

WHEREAS, the video of the Concert will be played on Doral TV and will be used to display the strength of the City's Commitment to the performing arts and to provide an opportunity to showcase the City nationwide;

WHEREAS, staff respectfully request that the City Council approve an expansion of the scope of services of TourFX for video production services and increase in the fees to TourFX in the amount of \$22,000.00, and authorize the manager to expend said funds.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> The expansion of the scope of services for TourFX in the Tri-Party Agreement to include video recording services and the increase in the fee to

TourFX by \$22,000.00 to cover the code of the video recording services is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to provide payment to Tour FX in the amount of \$22,000 for Video Production Services performed at the Forbidden Saints Concert that occurred on January 23rd, 2016.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and City Attorney are hereby authorized to take such other action as is necessary to implement the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
