The City of Doral authorizes the firm of A&P Consulting Transportation Engineers to provide professional engineering services for the development of a speed hump ordinance and the supplemental standards and criteria. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between A&P Consulting Transportation Engineers and the City of Doral dated January 30, 2018, and the attached Proposal submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCHEDULE:

The scope of the project will be as described in the attached proposal from A&P Consultant Transportation Engineers dated August 1, 2018 for the development of the ordinance and criteria. The schedule requires the draft report to be completed within 90 calendar days of the notice to proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a Time and Materials basis with a not to exceed amount of \$28,865.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 30, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.

RESOLUTION No. 18-158

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND A&P CONSULTING TRANSPORTATION ENGINEERS (APCTE), A PREQUALIFIED CITY VENDOR, TO PROCEED WITH THE DEVELOPMENT OF THE SPEED HUMP ORDINANCE IN AN AMOUNT NOT EXCEED \$28,865.00; APPROVING A BUDGET TRANSFER FROM TRANSPORTATION FUND ACCOUNT No. 101.80005.500650 (CONSTRUCTION IN PROGRESS) TO TRANSPORTATION FUND ACCOUNT No. 101.80005.500310 (PROFESSIONAL SERVICES); AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER, TRANSFER FUNDS, AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 77-52.a.3 of the City of Doral's Land Development Code does not allow speed bumps and/or humps; and

WHEREAS, the Public Works Department (PWD) has received multiple requests from residential communities for the installation of speed humps on private residential roads; and

WHEREAS, speed humps are vertical traffic calming devices intended to slow traffic speeds on low volume, low speed roads and the PWD is amenable with the implementation of speed humps that extend across the entire width of private roadways as they are effective at controlling speeds without posing safety risks; and

WHEREAS, the Code Compliance Department has also issued Notices of Violations to many residential communities that have installed speed humps and/or bumps without permits; and

WHEREAS, the PWD requested a proposal from APCTE to amend the existing Traffic Calming Ordinance in order to allow speed humps on private residential roads and

develop design criteria, standards, and guidelines for the permitting and implementation of the speed humps on private residential roadways; and

WHEREAS, APCTE is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, Staff respectfully requests that the City Council approve the Work Order with APCTE to proceed with the development of the Speed Hump Ordinance in an amount not exceed \$28,865.00; and

WHEREAS, the PWD respectfully requests that the City Council approve the budget transfer of \$28,865.00 from Transportation Fund Account No. 101.80005.500650 (Construction in Progress) to Transportation Fund Account No. 101.80005.500310 (Professional Services) for proper allocation of funds.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Work Order between the City of Doral and APCTE to develop the Speed Hump Ordinance; in an amount not to exceed \$28,865.00, a copy which is attached hereto as Exhibit "A", is hereby approved. The budget transfer of \$28,865.00 from Transportation Fund Account No. 101.80005.500650 (Construction in Progress) to Transportation Fund Account No. 101.80005.500310 (Professional Services) is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the work order and expend budgeted funds on the behalf of the City. The City Manager is

authorized to transfer the funds from Transportation Fund Account No. 101.80005.500650 (Construction in Progress) to Transportation Fund Account No. 101.80005.500310 (Professional Services).

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.
