## **RESOLUTION No. 10 – 45**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING THE PROPOSAL FROM BERMELLO AJAMIL & PARTNERS FOR CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR THE TRAFFIC CALMING DEVICES AND RIGHT-OF-WAY IMPROVEMENTS DESIGN BUILD PROJECT IN AN AMOUNT NOT TO EXCEED \$57,042.50; RECOGNIZING THAT BERMELLO AJAMIL & PARTNERS IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE (PUBLIC WORKS)

WHEREAS, in September 2009, the City of Doral, City Council authorized expenditures to move forward with the Traffic Calming Devices and Right-of-Way Improvements Design Build Project; and

WHEREAS, City of Doral Resolution No. 2007-89 pre-qualified ten (10) vendors, including Bermello, Ajamil & Partners (B&A), to provide services needed for capital improvement projects; and

WHEREAS, B&A submitted a proposal to provide construction engineering inspection (CEI) services for the Traffic Calming Devices and Right-of-Way Improvements Design Build Project; and

WHEREAS, Staff respectfully requests that the City Council approve said proposal from B&A in an amount not to exceed \$57,042.50.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> The City Council of the City of Doral hereby approves the proposal from B&A for the provision of CEI services for the Traffic Calming Devices and Right-of-Way Improvements Design Build Project in an amount not to exceed \$57,042.50.

Section 2. The City Council of the City of Doral further recognizes that B&A is a City of Doral pre-qualified vendor.

Section 3. This Resolution shall take effect immediately upon adoption.
