A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH GRANICUS, INC. FOR THE PROVISION OF WEB-BASED SOFTWARE TOOLS FOR ORGANIZING AND MANAGING PUBLIC MEETINGS IN AN AMOUNT NOT TO EXCEED \$24,915.00 PLUS \$1,140.00 PER MONTH FOR MANAGED SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in the interest of ensuring that the general public have consistent, effective, and efficient access to public information, the Office of the City Clerk seeks to update the capabilities and integration of the City's agendas, meeting minutes and meeting videos on the City's website; and

WHEREAS, Granicus, Inc. (Granicus) offers a set of web-based software tools designed to organize and manage public meetings; and

WHEREAS, aside from several other sole source provider services, Granicus is the sole source provider that integrates with MuniAgenda, an agenda solution previously purchased by the City of Doral, so as to allow for the instantaneous transmittal of a completed agenda and link said agenda to a pre-recorded meeting; and;

WHEREAS, Granicus is an existing sole source vendor for twenty five (25) municipalities throughout the State of Florida; and

WHEREAS, consistent with Section 12-9 of the City of Doral Purchasing Ordinance, Staff respectfully requests that the City Council waive the Request for Proposals (RFP) process and authorize the City Manager to negotiate and enter into an agreement with Granicus, Inc. for the provision of web-based software tools for organizing

and managing public meetings in an amount not to exceed \$24,915.00 plus \$1,140.00

per month for managed services.

Section 1. The City Council of the City of Doral hereby waives the Request for

Proposals (RFP) process and authorizes the City Manager to negotiate and enter into an

agreement with Granicus, Inc. for the provision of web-based software tools for organizing

and managing public meetings in an amount not to exceed \$24,915.00 plus \$1,140.00

per month for managed services.
