

RESOLUTION No. 20-60

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING AN OPEN PURCHASE ORDER FOR THE RETROFITTING OF FOUR (4) 2019 DODGE DURANGO PURSUIT UTILITY VEHICLES IN AN AMOUNT NOT TO EXCEED \$46,142.90 VIA CITY OF MIAMI CONTRACT #516388(21) WITH PUBLIC SAFETY SUPPLY; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE OPEN PURCHASE ORDER; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Police Department for the City of Doral (the "City") seeks an open purchase order for the retrofitting of four (4) 2019 Dodge Durango Pursuit Utility vehicles via the City of Miami, Contract #516388(21); and

WHEREAS, the four (4) marked police vehicles were not retrofitted during the time of purchase because the previous contract had expired and there had to be a new solicitation process in place. Procurement advertised ITB No. 2019-46 for Police Vehicle Retrofitting Services on December 31, 2019. A mandatory pre-bid meeting was held on January 14, 2020 with only one vendor in attendance. The meeting was cancelled due to lack of competition. Therefore, per Resolution No. 20-26 dated February 12, 2020, the Police Department will be utilizing the current City of Miami (Contract #516388(21)) with Public Safety Supply, as an awarded vendor for the installation of emergency equipment and accessories; and

WHEREAS, section 2-322 of the City Code of Ordinances authorizes the City to purchase goods and services via the contracts of other governmental entities, provided that such contracts have been achieved in a competitive manner similar to

those established in the City Code; and

WHEREAS, Staff recommends that the City Council authorize the City Manager to negotiate and enter into an agreement via the City of Miami Contract #516388(21) with Public Safety Supply for the retrofitting of four (4) new police vehicles in an amount not to exceed \$46,142.90, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code; and

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322, the open purchase order for the retrofitting of four (4) new police vehicles via the City of Miami Contract #516388(21) with Public Safety Supply, in an amount not to exceed \$46,142.90 is hereby approved. This purchase is funded from the Police Vehicles Account #001.60005.500641 with a transfer from the Contingent Reserve Account # 001.50005.500492.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the installation services under the City of Miami Contract, Public Safety Supply to expend funds in furtherance thereof in amounts not to exceed \$46,142.90.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilman Cabrera who moved its adoption.
