Chair Watts mentions spouse appreciation as a consideration but the need to wait until social distancing normalizes to hold such event.

Family Day is noted, usually held around December.

Chair Watts notes recommendation to the City Council to allow 100% disabled veterans free admission to the Doral Parks, specific to new activities to open at Doral Central Park.

Vice Chair Prather notes initiatives from the last board to continue pursuing. Encourage businesses to offer veteran discounts. Housing stipend or rental considerations for SouthCom members to live in Doral. Percentage of city contracts dedicated to veterans or disabled veterans; idea brought forward by the previous board but not actively pursued.

Board member Bautista notes creating a list of veterans that live in Doral for contact or recognition, outreach for local events.

Vice Chair Prather motions for board members to bring project ideas or initiatives to the next board meeting.

Board recommends December 11 to hold the next Family Day, will need verification and approval from the City Council this can be held Saturday, December 11, at Glades Park and waivers for entrance or operating fees will be approved.
