

RESOLUTION No. 23-96

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF THREE (3) NEW POLICE VEHICLES UTILIZING THE FLORIDA SHERIFFS ASSOCIATION CONTRACT No. FSA22-VEL30.0, WITH BOZARD FORD, IN AN AMOUNT NOT TO EXCEED \$136,392.00; AUTHORIZING THE CITY MANAGER TO EXECUTE A PURCHASE ORDER FOR THREE (3) FORD INTERCEPTOR UTILITY HYBRID VEHICLES IN AN AMOUNT NOT TO EXCEED \$136,392.00; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral ("City") Police Department is in need of three (3) Ford Police Interceptor Utility Hybrid vehicles; and

WHEREAS, Section 2-322 of the City Code Ordinances (the "Code") provides that the City may purchase supplies, materials, equipment and contractual services which are the subject of contracts through other governmental authorities or cooperatives; and

WHEREAS, the subject vehicles will be purchased via the Florida Sheriffs Association Contract No. FSA22-VEL30.0, in accordance with Section 2-322 of the City's Code; and

WHEREAS, the Public Works Department requests that the Mayor and City Councilmembers authorize the City Manager to proceed with the purchase of three (3) Ford Police Interceptor Utility Hybrid vehicles utilizing Florida Sheriffs Association Contract No. FSA22-VEL30.0, in an amount not to exceed \$136,392.00.

WHEREAS, sufficient funds are budgeted in the current Fiscal Year in the Fleet Replacement Fund, "Capital Outlay – Vehicles" Account, Account No.

304.50005.500641.for the purchase of the previously mentioned vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The purchase of three (3) 2023 Ford Police Interceptor Hybrid vehicles utilizing the Florida Sheriffs Association Contract No. FSA22-VEL30.0, pursuant to Section 2-322 of the City Code, in an amount not to exceed \$136,392.00 is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to purchase the three (3) 2023 Ford Police Interceptor Hybrid vehicles for the Police Department utilizing Florida Sheriffs Association Contract No. FSA22-VEL30.0, in an amount not to exceed \$136,392.00, and to expend the aforementioned budgeted funds in furtherance thereof.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Pineyro who moved its adoption. The motion was seconded by Councilmember Porras and upon being put to a vote, the vote was as follows:


