4. Discussion Items

a. Call to Artists: 2021-01 Acquisition of Works of Art Evaluation Criteria Phase II

Zafar Ahmed, Assistant Planning & Zoning Director, conducted Phase II of the Call to Artist Evaluation Criteria meeting. During the March 18, 2022, Advisory Board Meeting, the Planning and Zoning Department provided each board member with a list of artists and the application package consisting of 51 complete applications. On April 18, 2022, board members evaluated each art proposal and 10 artists were shortlisted.

Mr. Ahmed proceeded to explain the top 10 finalists will be presenting, and each board member will have 20 minutes to complete the Evaluation criteria for phase II based on the 6 evaluation criteria included below:
