

**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT BETWEEN
THE CITY OF DORAL, FLORIDA
AND
CALVIN, GIORDANO AND ASSOCIATES, INC.**

This First Amendment to Calvin, Giordano and Associates, Inc. Professional Services Agreement (PSA) made and entered into this 12 day of April, 2021, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and Calvin, Giordano and Associates, Inc. ("Consultant") having its place of business at 1800 Eller Drive, Suite 600, Fort Lauderdale, FL 33316, for the provision of finalizing the design and permitting of the Doral Boulevard Entry Monuments located along NW 41st Street at the interchange with the Palmetto Expressway.

WHEREAS, the City of Doral engaged the Consultant via Resolution 17-68 for the preparation of the 90% design plans for the Entry Monuments ("Project"); and

WHEREAS, CGA completed the 90% design plans and the City publicly advertised the project as a design-build receiving only one bid submittal; and

WHEREAS, the submittal received was over budget from the allocated funds as such the City dismissed the solicitation in order to finalize the 100% design and readvertise; and

WHEREAS, the original cost for the professional services contracted for the Project approved by the Professional Services Agreement was a not to exceed amount of \$57,171.00; and

WHEREAS, the City of Doral via Resolution 21-74 approved the increase of \$21,355.00 for a total not to exceed \$78,526.00 to cover the cost of the additional work; and

WHEREAS, Calvin, Giordano and Associates, Inc. Professional Services Agreement with the City of Doral was approved by the Mayor and the City Council-Members via Resolution No. 17-68.

NOW THEREFORE, in consideration of the mutual covenants set forth in this First Amendment, the parties agree as follows:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Amendments. The Professional Services Agreement is amended to include the additional scope of work and proposal dated February 2, 2021 from the Consultant.

EXCEPT AS PROVIDED HEREIN, all other terms and conditions of the PSA dated June 14, 2017, remain in full force and effect.





CGA HAS BEEN ADVISED TO PROCEED WITH THE FOLLOWING ADDITIONAL SERVICES:

Due to the client's request for work outside the original scope of services, Calvin, Giordano & Associates, Inc. will provide the following additional services:

CGA is providing this additional scope and services to address FDOT code required updates as they have been modified since the original scope was developed. Due to additional and modified scope of services, we respectfully submit this proposal to address these unforeseen issues. Note that these are not coordinated with any of the KCI plans. Understand that recently FDOT has a new rule that will only allow a City to apply online directly for a permit within that municipality. We would require the City of Doral to download the plan set to FDOT for this project.

I. Professional Engineering Services

A. Civil Engineering

1. Reissue utility correspondence letters to various utilities due to more than six months of time-lapse for FDOT Utility permitting and plans update.
2. Services provided previously but not included in previous contract: Plans and profiles for Directional boring across FDOT roadway.
3. Revise site grading plans for revised sign foundation size and dimensions.
4. No other services included unless specifically described above or in previous Contract.

B. Electrical Engineering

1. Revised electrical documents per new adapted Florida Building Code (FBC) 2020 6th Edition.
2. Verify with FPL proposed electrical service requirements due to change of FPL project manager for the area of work.
3. Prepare electrical documents for FDOT re-submittal.
4. Revisit specified gateway up-lights due to changes on manufacturer components and fixtures.
5. Items not included
 - Construction administration, including but not limited to, RFI's, shop drawings, cost estimates, field inspection and any items associated to be construction administration.
 - Field visits. Additional field visits can be provided as authorized additional services.

II. Professional Landscape Architecture Services

- A. CGA will provide responses to the comments by FDOT and address the issues relative to the recent modifications to the FDOT requirements.
- B. Provide revisions to the plans which were originally designed, detailed and specified per the former FDOT Plans Preparation Manual. The requirements now reference the FDOT new references from 2018. As this project has been underway for many years, the standards have changed and many of the comments require modifications to the FDOT Design Standards.
- C. This scope includes the coordination of the plans with the other disciplines as well as the coordination with city staff.

III. Professional Surveying Services

- A. Locate and establish the limits of right-of-way for N.W. 77th Avenue at the intersection of N.W. 36th Street and the FDOT right-of-way of N.W. 36th Street west of the Palmetto Expressway.
- B. Obtain additional topographic spot elevations as required for engineering design.
- C. Locate additional trees and verify status of trees from previous survey as required for tree disposition plan.
- D. Perform a QA\QC on previous survey information and locate any changes and\or deletions.

RESOLUTION No. 21-74

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE THE FIRST AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH CALVIN, GIORDANO AND ASSOCIATES, INC. TO COMPLETE THE DESIGN AND PERMITTING PHASE OF THE DORAL BOULEVARD ENTRY MONUMENTS IN AN AMOUNT OF \$21,355.00 FOR A TOTAL NOT TO EXCEED AMOUNT OF \$78,526.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE PROFESSIONAL SERVICES AGREEMENT AMENDMENT AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City approved Resolution 17-68 awarding the design and construction administration to Calvin, Giordano & Associates, Inc. (CGA); and

WHEREAS, on June 14, 2017 the City entered into a Professional Services Agreement (PSA) with CGA to provide the 90% design and construction administration services as approved by the Mayor and the City Council-Members via Resolution No. 17-68, in an amount not to exceed \$57,171.00; and

WHEREAS, CGA has completed the 90% design and the project was advertised as a design-build; and

WHEREAS, Request for Proposal (RFP) No. 2020-30, "Doral Boulevard Entry Monuments" was opened on December 14, 2020, for the design and construction of the proposed entry monuments along Doral Boulevard at the Palmetto Expressway interchange; and

WHEREAS, the City only received one proposal for RFP 2020-30 and decided not to move forward with the process as the proposed cost exceeded available funding,

and instead decided to finalize the design and advertise the construction phase of the project as an Invitation to Bid (ITB); and

WHEREAS, CGA completed the 90% design plans and the PWD requested a proposal to complete the 100% design and permit the project; and

WHEREAS, City staff and CGA negotiated the attached proposal on a lump sum basis in an amount not to exceed \$21,355.00; and

WHEREAS, City staff respectfully requests that the City Council approve the Amendment to the previously approved (Resolution No. 17-68) Professional Services Agreement with Calvin, Giordano & Associates, Inc. a copy which is attached hereto as Exhibit "A", for the final completion of the design and permitting phase in the amount of \$21,355.00, for a revised total not to exceed amount of \$78,526.00; and

WHEREAS, funding for this request is available in the current Fiscal Year in the Public Works Department Transportation Fund, Account Num. 101.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Amendment to the Professional Services Agreement between the City of Doral and Calvin, Giordano & Associates, Inc. for design and permitting services, in an amount not to exceed \$21,355.00, a copy which is attached

hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, is hereby approved.

Section 3. Authorization. The City Manager is authorized to execute the Amendment to the Professional Services Agreement and expend budgeted funds on the behalf of the City in furtherance hereof.


Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.
