

RESOLUTION No. 21-223

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH HORSEPOWER ELECTRIC, INC., SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR ELECTRICAL DESIGN AND SERVICES NOT TO EXCEED AMOUNT OF \$5,800.00 FOR DORAL CULTURAL ARTS CENTER AND \$6,600.00 FOR DORAL WHITE COURSE PARK; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Since the FY17-18 Strategic Plan, the City has invested in Smart City Strategy internal components developing the infrastructure that will enable the City to operate more efficiently and effectively, improve internal communication and be better able to manage and analyze data in order to better understand issues related to the City; and

WHEREAS, LPR provides insight into daily license plate detections that enter and exit our City among many more statistics. In addition, the City of Doral Police Departments utilizes the LPR cameras during all sorts of investigations. For this reason, we should install the proposed LPR's at the City parks listed during the scheduled renovations; and

WHEREAS, In June 2018, the Mayor and Council approved Resolution 18-100 that authorized staff to use the established Horsepower Electric, Inc., pricing for construction of additional License Plate Reader infrastructure at other intersection. As required, any additional construction will be presented to Council for approval. As per Reso. 18-100 we respectfully request approval of Horsepower Electric Inc, for Electrical Design and services in not to exceed amount of \$5,800 for Doral Cultural Arts Center and \$6,600.00 for Doral White Course; and

WHEREAS, staff respectfully recommends the Mayor and City Council members authorize the City Manager to enter into an agreement with Horsepower Electric Inc, for Electrical Design and services in not to exceed amount of \$5,800 for Doral Cultural Arts Center and \$6,600.00 for Doral White Course Park. Funds for Doral Cultural Arts Center are allocated in the Doral Parks Bond – Construction In Progress Account #303.9005572.500650 and funds for White Course Park are allocated in the Doral Parks Impact Fees Account 102.90005.500650; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Authorization. The City Manager is hereby authorized to the City Manager to enter into an agreement with Horsepower Electric Inc, for Electrical Design and services in not to exceed amount of \$5,800 for Doral Cultural Arts Center and \$6,600.00 for Doral White Course Park. Funds for Doral Cultural Arts Center are allocated in the Doral Parks Bond – Construction In Progress Account #303.9005572.500650 and funds for White Course Park are allocated in the Doral Parks Impact Fees Account 102.90005.500650.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.
