A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A WORK ORDER BETWEEN THE CITY OF DORAL AND KIMLEY HORN, A PREQUALIFIED CITY VENDOR, FOR THE PROVISION OF CONSTRUCTION ENGINEERING INSPECTION SERVICES FOR THE NW 66 STREET ROADWAY CONSTRUCTION PROJECT BETWEEN NW 102 AVENUE AND NW 97 AVENUE IN AN AMOUNT NOT TO EXCEED \$129,548.50; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City"), through its Public Works Department, wishes to secure a firm to provide Construction Engineering Inspection services ("CEI Services") for the construction of roadway improvements on NW 66 Street between NW 102 Avenue and NW 97 Avenue ("Project"); and

WHEREAS, Kimley Horn is a pre-qualified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in December 2014; and

WHEREAS, City staff has recommended that the City Council approve "Work Order No. 4" for Kimley Horn, a copy of which is attached hereto as Exhibit "A", for the provision of CEI services for the construction of the Project in an amount not to exceed \$129,548.50, and authorize the City Manager to execute the Work Order No. 4 and to expend budgeted funds in furtherance hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
