

**RESOLUTION NO. 04-50**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF CITY OF DORAL, FLORIDA, SUPPORTING SENATE BILL 2572 WHICH PROVIDES EXCEPTIONS FROM CERTAIN AIRPORT ZONING PROHIBITIONS IN CHAPTER 333, FLORIDA STATUTES AND PROVIDES FOR THE PLACEMENT OF EDUCATION FACILITIES IN AREAS NEAR AIRPORTS; DIRECTING THE CITY CLERK TO TRANSMIT THIS RESOLUTION TO GOVERNOR JEB BUSH; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Mayor and City Council have an interest in providing more schools for the children of the City of Doral; and

**WHEREAS**, Chapter 333, Florida Statutes, as currently written, provides overbroad and undue restrictions on the location of schools in the City of Doral as it is located in near proximity to a major airport; and

**WHEREAS**, Senate Bill 2572 exempts Miami-Dade County from the provisions of Section 333.03, Florida Statutes, as it relates to the construction of educational facilities; and

**WHEREAS**, Senate Bill 2572 received a unanimous vote in both the House and Senate of the State Legislature; and

**WHEREAS**, the Mayor and City Council of the City of Doral believe that the passage of Senate Bill 2572 is in the best interests of the citizens of the City of Doral and, in particular, of its children;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1.** The City of Doral is in favor of Senate Bill 2572 and respectfully urges Governor Jeb Bush to sign same into law.

**Section 2.** The City Clerk is hereby directed to transmit this Resolution to Governor Jeb Bush.

**Section 3.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Cabrera, who moved its adoption. The motion was seconded by Councilman Van Name and upon being put to a vote, the vote was as follows:


