

**RESOLUTION NO. 12-25**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH PROFESSIONAL SERVICES INDUSTRIES (PSI) FOR THE PROVISION OF GEOTECHNICAL AND CONSTRUCTION MATERIALS TESTING FOR THE CONSTRUCTION OF THE PUBLIC WORKS MAINTENANCE FACILITY IN AN AMOUNT NOT TO EXCEED \$19,960.60; RECOGNIZING THAT PSI IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, in order to ensure that construction materials, products and applications are in accordance with the design and applicable building construction codes for the construction of the public works maintenance facility, the Public Works Department requested proposals for geotechnical and materials testing for construction of this facility from four (4) sub-consulting firms; and

**WHEREAS**, these sub-consulting firms were pre-qualified from a pool of engineering and architecture firms approved during the October 2011, City Council Meeting; and

**WHEREAS**, upon review of the proposals received, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with PSI for the provision of geotechnical and construction materials testing for the construction of the public works maintenance facility in an amount not to exceed \$19,960.60.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with PSI for the provision of geotechnical and construction materials testing for the construction of the public works maintenance facility in an amount not to exceed \$19,960.60.

**Section 2.** This Resolution shall become effective immediately upon adoption.
