A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ADJUSTING THE CITY'S GENERAL FUND BUDGET AND THE G.O. PARKS BOND SERIES 2019 AND 2021 FOR FISCAL YEAR 2020-2021, BY APPROVING BUDGET TRANSFERS WITHIN THE GENERAL FUND AND THE G.O. PARKS BOND SERIES 2019 AND 2021 FUNDS WITH NO NET INCREASE IN THE APPROPRIATIONS TO THE FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") experienced a need to expend more funds in certain accounts and less in other accounts within the General Fund budget and the G.O. Bond Series 2019 and 2021 Fund budgets during the 2020-2021 fiscal year; and

WHEREAS, Section 166.241, Florida Statutes, provides that a city council may by resolution at any time during a fiscal year and within sixty days following the end of the fiscal year amend a budget to reflect increases and decreases in expenditures within a fund within the budget provided that the total amount of the appropriations is not changed; and

WHEREAS, the City finds it necessary to adjust the City's General Fund Budget and the G.O. Bond Series 2019 and 2021 Fund budgets for Fiscal Year 2020-2021 (the "Budget") in order to reflect the expenses correctly;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Budget Amendment.</u> The City Council of the City of Doral, Florida hereby adjusts the Fiscal Year 2020-2021 General Fund Budget and G.O. Parks Bond

Series 2019 and 2021 Funds and authorizes the budget transfers set forth on EXHIBIT A hereto.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

Section 4. Effective Date. This resolution shall take effect immediately upon adoption.
