

RESOLUTION NO. 12 -50

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO EXTEND THE EXISTING AGREEMENT WITH GONZALEZ & SONS, INC. TO COVER THE PORTION GRANTED BY THE NATIONAL RESOURCES CONSERVATION SERVICE ON YEAR 3.B OF THE CANAL BANK STABILIZATION PROGRAM IN THE AMOUNT OF \$957,278.43; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral awarded Gonzalez & Sons, Inc. (G&S) with the contract for Year 1 and Year 2 of the Canal Bank Stabilization Program; and

WHEREAS, on June 28, 2011 the Natural Resources Conservation Service (NRCS) and the City of Doral executed an agreement providing the City a grant totaling \$1.8 million to fund a portion of Year 2 and Year 3 of the Canal Bank Stabilization Project; and

WHEREAS, due to the time constraint set by the Grant, good performance on the Contractor's behalf, and the honoring of the original prices from the original bid, City of Doral Resolution #11-154 extended G&S's contract to include the granted portion of Year 3 (referred to as Year 3.A.) for an amount not to exceed \$1,451,360.08; and

WHEREAS, Year 3.A. was completed on April 13, 2012 and, on February 8, 2012, the City Council accepted an additional \$1 million granted by NRCS to finalize the remaining portion of Year 3 of the program (referred to as Year 3.B); and

WHEREAS, if the savings from Year 2 and Year 3.A. were reallocated, the City would require only \$957,278.43 to complete Year 3.B.; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to extend the existing agreement with G&S to cover the portion granted by the NRCS on Year 3.B. of the Canal Bank Stabilization Program in the amount of \$957,278.43.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council hereby authorizes the City Manager to extend the existing agreement with G&S to cover the portion granted by the NRCS on Year 3.B. of the Canal Bank Stabilization Program in the amount of \$957,278.43.

Section 2. This Resolution shall become effective immediately upon its adoption.
