

**RESOLUTION No. 08 - 76**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA; ESTABLISHING A PROPOSED MILLAGE RATE OF 2.447 TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2008-2009, ESTABLISHING THE CURRENT YEAR ROLLED-BACK RATE TO BE 2.3061 AND ESTABLISHING THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CLERK AND MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE AND THE STATE OF FLORIDA; ESTABLISHING THE TIME AND LOCATION OF THE FIRST AND SECOND PUBLIC HEARINGS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on July 1, 2008, the Honorable Marcus L. Saiz de la Mora, Director, Miami-Dade County, Florida Property Appraiser Office, served upon the City of Doral a "Certification of Taxable Value" certifying to the City of Doral its 2007 taxable value; and

**WHEREAS**, the provisions of Florida Statutes Section 200.065 require that within thirty five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a first public hearing will be held to consider the proposed millage rate and tentative budget; and

**WHEREAS**, The City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

**WHEREAS**, The City Council has reviewed the figures supplied by the Property Appraiser of Miami-Dade County and that being otherwise fully advised in the premises;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:**

**Section 1.** That the proposed millage for the first public hearing is hereby declared to be 2.447 mills which is \$2.447 per \$1,000.00 of assessed property within the City of Doral.

**Section 2.** That the City Council further confirms the current year rolled back rate computed pursuant to section 200.065 F.S., is 2.3061 mills which is \$2.31 per \$1,000.00 of assessed property within the City of Doral.

**Section 3.** That the date, time and place of the first and second public hearings are hereby set by the City Council as follows:

**Section 4.** That the City Clerk and City Manager are directed to attach the original Certification of Taxable Value to a certified copy of this Resolution and serve the same upon the Honorable Marcus L. Saiz de la Mora, Director, Miami-Dade County, Florida Property Appraiser Office on or before July 31, 2008.

**Section 5.** This Resolution shall be effectively immediately upon adoption.


