## RESOLUTION NO. 12-36

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH INNOCORP, LTD. FOR THE PROVISION OF A SIMULATED IMPAIRED DRIVING EXPERIENCE, INCLUDING THE TRAILER AND TRAINING, IN AN AMOUNT NOT TO EXCEED \$29,330.67; RECOGNIZING THAT INNOCORP, LTD. IS A SOLE SOURCE PROVIDER OF THESE SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department seeks to purchase a Simulated Impaired Driving Experience (SIDNE) with trailer and training from Innocorp, Ltd. (Innocorp); and

WHEREAS, pursuant to Section 2-323 of the City Code and Section 287.057, F.S., Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Innocorp for the provision of a SIDNE, including the trailer and training, in an amount not to exceed \$29,330.67 based on this vendor's status as being a sole source provider and recognize that all procedures detailed in Section 287.057, F.S. have been followed

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby authorizes the City Manager to negotiate and enter into an agreement with Innocorp for the provision of a SIDNE, including the trailer and training, in an amount not to exceed \$29,330.67 based on this vendor's status as being a sole source provider; and recognizes that all procedures detailed in Section 287.057, F.S. have been followed.

**Section 2.** This Resolution shall become effective immediately upon adoption.
