

**RESOLUTION No. 21-69**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE RECURRING ANNUAL SUBSCRIPTION AND LICENSES COST FROM POWERDETAILS IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Mayor and Council approved the Edward Byrne Justice Assistance Grant-County-Wide (JAGC): Records Improvement as a reimbursable grant in April, 2019 per Resolution No. 19-93. The City of Doral Police Department used the allocated funds to purchase an extra duty management software package to efficiently organize and communicate special events and extra duty all while automatically enforcing our policy. The 2019 Resolution allocated a specific dollar amount for the purchase of the yearly subscription. Due to the 3% yearly increase of the subscription cost, we find it necessary not include a specific cost due to the yearly increase. We will not exceed yearly budgeted funds allocated for this subscription.

**WHEREAS**, Staff respectfully requests that the Mayor and City Council authorize the annual recurring subscription and licenses cost in an amount not to exceed budgeted funds.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Manager hereby authorizes the annual recurring subscription and licenses cost from PowerDetails in an amount not to exceed budgeted funds from IT Department's Repair and Maintenance-Office Equipment-Other

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.
