

**RESOLUTION No. 10 – 56**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ADOPTING THE COMPETITIVELY BID TERMS OF THE AGREEMENT BETWEEN VILA & SONS LANDSCAPING CORPORATION AND PALM-BEACH COUNTY, FLORIDA FOR THE PROVISION OF TREE INSTALLATION IN THE CITY OF DORAL IN AN AMOUNT NOT TO EXCEED \$100,000.00; DIRECTING THE CITY MANAGER AND THE CITY ATTORNEY TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH VILA & SONS LANDSCAPING CORPORATION ON THE BASIS OF SAID TERMS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral had an agreement with Vila & Sons Landscaping Corporation (Vila & Sons) for the installation of trees which expired in September 2009; and

**WHEREAS**, Palm Beach County, Florida has an existing competitively bid agreement with Vila & Sons for the installation of trees; and

**WHEREAS**, pursuant to Section 12-10 of City of Doral Ordinance #2004-03 titled "Purchasing and Procurement," Staff respectfully requests that the City Council of the City of Doral adopt the competitively bid terms of the agreement between Vila & Sons and Palm Beach County, Florida for the provision of tree installation in the City of Doral in an amount not to exceed \$100,000.00; and

**WHEREAS**, Staff further requests that the City Council direct the City Manager and the City Attorney to negotiate and enter into an agreement with Vila & Sons on the basis of the terms stated in the above "whereas" clause.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council of the City of Doral hereby adopts the competitively bid terms of the agreement between Vila & Sons and Palm Beach County, Florida for the provision of tree installation in the City of Doral in an amount not to exceed \$100,000.00.

**Section 2.** The City Council of the City of Doral further directs the City Manager and the City Attorney to negotiate and enter into an agreement with Vila & Sons on the basis of the terms stated in Section 1 of this Resolution.

**Section 3.** This Resolution shall take effect immediately upon adoption.
