

**RESOLUTION NO. 13-57**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORA, FLORIDA AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE FLORIDA DIVISION OF CULTURAL AFFAIRS CULTURAL FACILITIES PROGRAM REQUESTING \$500,000.00 FOR THE N.W. 114th AVENUE PARK COMMUNITY CENTER PROJECT; FURTHER AUTHORIZING AN AMOUNT OF \$1,000,000.00 AS THE CITY'S REQUIRED MATCHING FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Doral has the opportunity to apply for funding in the amount of \$500,000.00 the Cultural Facilities Program for the N.W.114th Avenue Park Community Center Project, with a 2 to 1 stipulation for matching funds; and

**WHEREAS**, funding in the amount of \$1,000,000.00, necessary for the required match, will be available by July 1, 2013;

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:**

**Section 1.** The City Council hereby authorizes the submission of a grant application to the Florida Division of Cultural Affairs Cultural Facilities Program to request \$500,000.00 for the N.W. 114<sup>th</sup> Avenue Park Community Center project.


**Section 2.** The City Council further authorizes an expenditure of \$1,000,000.00 to be available by July 1, 2013 for required matching funds for the grant application to the Florida Division of Cultural Affairs in a search for funding for the N.W. 114th Avenue Park Community Center project.


