

**RESOLUTION No. 23-92**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT AND USE OF THE CITY LOGO REQUESTED BY FUNDACION COLOMBO AMERICANOS UNIDOS TO HOST THE “COLOMBIAN INDEPENDENCE DAY FESTIVAL” EVENT AT DOWNTOWN DORAL PARK LOCATED AT 8395 NW 53 STREET, DORAL, FL, ON SATURDAY, JULY 22, 2023, FROM 6:00 PM TO 11:00 PM; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Fundación Colombo Americanos Unidos (the “Applicant”) seeks approval from the Mayor and City Council of a special event permit to host the Colombian Independence Day Festival on Saturday, July 22, 2023, at Downtown Doral Park located at 8395 NW 53 Street, Doral, FL, from 6:00 p.m. to 11:00 p.m.; and

**WHEREAS**, the purpose of the Colombian Independence Day Festival is to promote Colombian culture locally and throughout Miami-Dade County; and

**WHEREAS**, the Applicant further requests approval of the Mayor and City Council to use the City logo for marketing and advertising purposes; and

**WHEREAS**, City staff reviewed the special event permit application and recommend that the Mayor and City Council approve the proposed special event permit, and authorize the Applicant to utilize the City logo.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The special event permit for the Colombian Independence Day Festival is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. The Applicant shall be required to have all inspections and approvals prior to the event date.
3. Sanitary facilities shall be provided by the applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
5. The Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
6. The Applicant shall comply with comments made by the City of Doral Parks and Recreation Department and pay all applicable fees no later than 14 days in advance of the event.
7. The Applicant shall provide copy of parking agreement(s) to the Planning and Zoning Department thirty (30) days prior to event start date.
8. The Applicant shall turn off all speakers, musical instruments, etc., by 11:00 p.m. on July 22, 2023.
9. The Applicant shall provide to the City of Doral an acceptable certificate of insurance four weeks prior to the event date. If alcoholic beverages are to be dispensed, served, sold or distributed at the special event, the dispensing, serving, sales and/or distribution of alcoholic beverages shall be factored into the amount of insurance coverage in accordance with section 74-194 of the City's Land Development Code.
10. The Applicant shall obtain approval from the State of Florida Division of Alcoholic Beverages and Tobacco for the sale of alcoholic beverages prior to event start date. Proof of approval shall be submitted to the Planning and Zoning Department no later than 10 days in advance of the event start date.
11. The Applicant must submit to the planning and zoning director for approval a description of the control measures to be imposed and where alcohol will be stored, served and sold.

**Section 3. Use of City Logo.** Fundación Colombo Americanos Unidos is hereby authorized to utilize the City logo in connection with the special event approved herein for marketing and advertising purposes.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Vice Mayor Pineyro who moved its adoption. The motion was seconded by Councilmember Porras and upon being put to a vote, the vote was as follows:
