

RESOLUTION No. 23-121

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE PURCHASE OF RUBRIK CENTRALIZED DATA STORAGE LICENSING, SUPPORT AND ENTERPRISE SERVICES FOR MANAGEMENT CONTROL AND DATA INTELLIGENCE FROM ALTURNA TECH VIA CARAHSOFT GSA SCHEDULE No. 47QSWA18D008F, IN AN AMOUNT NOT TO EXCEED \$57,118.20 FOR A ONE YEAR TERM; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on August 13, 2019, the City of Doral (“City”) approved Resolution No. 19-162, for the purchase of Rubrik centralized data storage equipment, licensing, support, and enterprise services from an authorized dealer, Alturna Tech; and

WHEREAS, Rubrik offers the industry’s most comprehensive portfolio of government security certifications, allowing military and civilian agencies to confidently backup, replicate, and archive data while complying with rigid data protection policies regarding classified, confidential, or personally identifiable information (“PII”); and

WHEREAS, the City having been satisfied with the software and services provided, authorized the purchase of Rubrik software from Alturna Tech for an additional one year term pursuant to Resolution 22-115; and

WHEREAS, the aforementioned term is scheduled to expire, and it is the recommendation of City staff that the City continue to utilize Rubrik as it is compatible with the City’s current network infrastructure; and

WHEREAS, Section 2-322 of the City’s Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

WHEREAS, Alturna Tech is an authorized dealer of Rubrik software and is a participating vendor in Carahsoft GSA Schedule No. 47QSWA18D008F, as specified in the quote; and

WHEREAS, the City Manager's Office respectfully requests that the Mayor and City Councilmembers approve the purchase of Rubrik centralized data storage licensing, support, and enterprise services for management control and data intelligence in an amount not to exceed \$57,118.20, from Alturna Tech utilizing Carahsoft GSA Schedule No. 47QSWA18D008F; and

WHEREAS, funds for this purchase are allocated yearly in the IT Repair and Maintenance Account# 001.22005.500460.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Council hereby approves the purchase of Rubrik centralized data storage licensing, support, and enterprise services for management control and data intelligence in an amount not to \$57,118.20 from Alturna Tech utilizing Carahsoft GSA Schedule No. 47QSWA18D008F. Funds are allocated yearly in the IT Repair and Maintenance Account# 001.22005.500460.

Section 3. Authorization. The City Manager is hereby authorized to execute a purchase order to effectuate the aforementioned purchase, and to expend the budgeted funds.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 5. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Vice Mayor Pineyro who moved its adoption.
