

**RESOLUTION NO. 12 – 155**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE COMPETITIVE BIDDING PROCESS, PURSUANT TO SECTION 2-321 OF THE CITY CODE AS IT IS IN THE BEST INTEREST OF THE CITY TO DO SO, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH CRISTI'S DANCE STUDIO FOR THE PROVISION OF BALLET DANCE PROGRAMMING SERVICES AT CITY OF DORAL PARKS FOR A POSSIBLE TOTAL PERIOD OF ONE (1) YEAR IN AN AMOUNT NOT TO EXCEED \$35,000.00 PER YEAR; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Cristi's Dance Studio has provided ballet dance programming services in the City of Doral for over four (4) years and surveys conducted by City Staff have indicated a high level of satisfaction with this service by Doral residents; and

**WHEREAS**, pursuant to Section 2-321 of the City Code, Staff respectfully requests that the City Council waive the competitive bidding process, as it is in the best interest of the City to do so, and authorize the City Manager to negotiate and enter into an agreement with Cristi's Dance Studio for the continued provision of ballet dance programming in City of Doral parks for a total period of one (1) year in an amount not to exceed \$35,000.00 per fiscal year.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**


**Section 1.** The City Council hereby waives the competitive bidding process as it is in the best interest of the City to do so, and authorizes the City Manager to negotiate and enter into an agreement with Cristi's Dance Studio for the continued provision of ballet dance programming in City of Doral parks for a total period of one (1) year in an amount not to exceed \$35,000.00 per fiscal year.

**Section 2.** This Resolution shall become effective immediately upon its adoption.


