

**RESOLUTION NO. 12 -51**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH BCC ENGINEERING FOR THE PROVISION OF DESIGN, CONSTRUCTION ADMINISTRATION AND INSPECTION SERVICES FOR THE DORAL TROLLEY INFRASTRUCTURE IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$59,777.00; RECOGNIZING THAT BCC ENGINEERING IS A CITY OF DORAL PRE-QUALIFIED VENDOR; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Public Works Department continually reviews the Doral Trolley program to ensure that it is transit friendly, pleasing and safe; and

**WHEREAS**, based on the ridership data and infrastructure needs assessment identified at each stop location, certain infrastructure improvements are being recommended; and

**WHEREAS**, BCC Engineering (BCC), a City of Doral prequalified vendor, has submitted a proposal to provide design, construction administration and inspection services for the Doral Trolley infrastructure improvements identified by the Public Works Department; and

**WHEREAS**, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with BCC for the provision of design, construction administration and inspection services for the Doral Trolley infrastructure improvements in an amount not to exceed \$59,777.00.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1.** The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with BCC for the provision of design, construction administration and inspection services for the Doral Trolley infrastructure improvements in an amount not to exceed \$59,777.00.

**Section 2.** The City Council further recognizes that BCC is a City of Doral pre-qualified vendor.

**Section 3.** This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilman Cabrera who moved its adoption. The motion was seconded by Vice Mayor DiPietro and upon being put to a vote, the vote was as follows:
