

**RESOLUTION No.15-231**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN OUTDOOR EVENT PERMIT FOR MARY KAY ASH FOUNDATION TO HOST THE “PEACE OF YOUR HEART 5K/FIGHTING DOMESTIC VIOLENCE AND ABUSE” EVENT AT DORAL CENTRAL PARK, LOCATED AT 3000 NW 87<sup>TH</sup> AVENUE, ON SATURDAY, FEBRUARY 13, 2016 FROM 7:00AM TO 12:00PM; PROVIDING FOR CONDITIONS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Mary Kay Ash (“Applicant”) seeks approval from the City of Doral for an Outdoor Event Permit; and

**WHEREAS**, staff has recommended that Council approve the Applicant’s proposed Outdoor Event Permit to host the “Peace of Your Heart 5K/Fighting Domestic Violence and Abuse” event on Saturday, February 13, 2016 from 7:00am to 12:00pm, at Doral Central Park located at 3000 NW 87th Avenue, Doral, Florida 33172.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The outdoor events permit for the “Peace of Your Heart 5K/Fighting Domestic Violence and Abuse” event is hereby approved subject to the following conditions:

1. Applicant shall comply with the conditions proposed or adopted by the Mayor and City Council;
2. Applicant shall comply with the comments made by the City of Doral Police Department;

3. Applicant shall comply with acquiring all required permits and performing the necessary inspections prior to event, given by the City of Doral Building Department;
4. Applicant shall comply with the comments made by the City of Doral Parks and Recreation Department; and
5. Applicant shall provide an adequate certificate of insurance prior to the event.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby further authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
