

**RESOLUTION No. 19-310**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A BUDGET TRANSFER IN THE AMOUNT OF \$50,000.00 FROM ACCOUNT 001.50005.500340 TO OTHER PUBLIC AFFAIRS DIVISION AND GENERAL FUND EXPENSE ACCOUNTS FOR THE CENSUS 2020 EDUCATIONAL CAMPAIGN; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the June 12, 2019 Council Meeting, Council unanimously approved the establishment of a complete count committee comprised of individuals from diverse sectors to work collaboratively on a campaign to mobilize the City of Doral residents to be counted in the Census 2020. City Staff is working with the committee to devise and execute campaign not exceeding \$50,000; and

**WHEREAS**, the City will be deploying an educational campaign consisting of multiple outreach efforts including: direct mailers, brochures, bus benches, newspaper ads, workshops, etc. for the purpose of transparency with our residents and to provide all the pertinent information so they may have a clear understanding of the process and how important it is that they participate and “count”; and

**WHEREAS**, while funds needed to carry out this educational campaign are in the FY 19-20 budget, they are not in the specific and adequate accounts for the Public Affairs Division to utilize; and

**WHEREAS**, staff respectfully requests approval to transfer funds allocated for this campaign under the 001.50005.500340 account to the Public Affairs Division and General Fund expense accounts in the amount of \$50,000.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Council hereby approves the transfer of funds in the amount of \$50,000.00 from account 001.50005.500340 to the Public Affairs Division expense accounts to be utilized for the Census 2020 Educational Campaign as follows -- 001.1150.519.500470 (\$21,810.00), 001.1150.519.500481 (16,390.00), 001.1150.519.500490 (\$800.00), and 001.1150.519.500410 (11,000).

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

**Section 5. Effective Date.** This resolution shall take effect immediately upon adoption.
