TOTAL AMOUNT: \$27,789.30 (Not to exceed)

PROJECT SCOPE OF WORK: The City of Doral authorizes the firm of H & R Paving, Inc., to proceed with the sidewalk repair/replacement at the following location and as shown on the attached exhibit: N.W. 78th Street (N.W. 108th Place to N.W. 109th Avenue). The work includes sidewalk replacements with Geosynthetic Reinforcement due to ground settlement, in accordance with Contract specifications and in conformity with the lines, grades and dimensions of existing conditions. All concrete repairs will comply with Miami-Dade County Public Works Manual Part I Design and Construction Section R-13.1 Standard Road Detail Sidewalk Construction. The scope of the project is described more fully in the Contract Documents, (ITB#2014-06) "Remove / Replace Sidewalks, Curbs / Gutter Miscellaneous Stormwater Improvements and Milling Resurfacing of Bituminous Paving" Agreement.

If Contractor fails to execute said Work Order in a timely manner and complete all work within 30 calendar days from the time this work order is executed, the City of Doral will be entitled to disqualify the Proposal, and revoke the award.

The performance of services associated with this Work Order will be executed on a 'Line Item' basis with a not to exceed amount of \$27,789.30 including 10% contingency.



- · Contractor to restore all areas disturbed.



Sidewalk Replacement with Geosynthetic Reinforcement

Notes:

- Geosynthetic Reinforcement to be Tensar BX-1200 or Similar Geogrid
- Geogrid shall be bi-axial with a minimum allowable tensile strength of 340 lb/ft.
- Geogrid to be installed 6 inches below bottom of new cast in place sidewalk.
- Contractor to remove existing sidewalk and excavate 12 inches vertically and six inches laterally into sodded areas. Cost to be included in the cost of the geogrid reinforced sidewalk.
- Cost to reset Bus Stop Bench shall be included in the cost of the geogrid reinforced sidewalk.
- Approximate Square Footage of New Sidewalk: 1,205 square feet
- Harmonize 2 inches below new back of sidewalk to existing ground elevation.
- · Contractor to restore all areas disturbed.

RESOLUTION NO. 14-51

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA ACCEPTING THE LOW BID AND APPROVING A CONTRACT BETWEEN THE CITY AND H&R PAVING FOR THE PROVISION OF CITYWIDE REMOVAL AND REPLACEMENT OF SIDEWALKS, CURB AND GUTTER, MISCELLANEOUS STORMWATER IMPROVEMENTS, AND MILLING AND RESURFACING OF BITUMINOUS PAVING IN AN AMOUNT NOT TO EXCEED \$3,450,000.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in response to ITB #2014-06 titled "Removal / Replace Sidewalks, Curb and Gutter, Miscellaneous Stormwater Improvements, and Milling and Resurfacing of Bituminous Paving" (the "Project"), the City of Doral received three (3) bids by the February 18, 2014 deadline with all three (3) companies meeting the required criteria; and

WHEREAS, upon review of bids received, Staff determined that H&R Paving, Inc. was the lowest most responsive and responsible bidder (the "Contractor"); and

WHEREAS, a copy of Contractor's Bid Submittal, ITB #2014-06 Inventory, Bid Tabulation, and contract agreement are attached as Exhibit A; and

WHEREAS, the City Council finds that accepting the bid and entering into a contract for the Project with the Contractor is in the best interest of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are true and correct and incorporated herein.

Section 2. Approval. The Contract between the City and Contractor for the Project in an amount not to exceed \$3,450,000.00 (which includes a 10% contingency amount for unforeseen conditions) and a contract duration of one (1) year with the option to renew for an additional two one (1) year periods, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney, is hereby approved. The City Manager is authorized to execute the Contract and expend budgeted funds on behalf of the City.

<u>Section 3.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilmember Ruiz who moved its adoption.
