# **RESOLUTION No. 16-130**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN INTERLOCAL AGREEMENT WITH THE MIAMI-DADE COUNTY DEPARTMENT OF REGULATORY AND ECONOMIC RESOURCES FOR THE 2016 ADOPT-A-TREE PROGRAM; AUTHORIZING THE CITY MANAGER TO EXPEND AN AMOUNT NOT TO EXCEED OF \$15,000.00 ENCUMBERED FROM FISCAL YEAR 2013-2014 FOR THE SEPTEMBER 2016 ADOPT-A-TREE EVENT AT DORAL CENTRAL PARK; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Adopt-a-Tree event was a great success whereby the City of Doral (the "City") has provided over 8,275 trees to our community due to the value they provide to our urban forest; and

WHEREAS, the event will be hosted and sponsored by the City and cosponsored by the Miami-Dade County Department of Regulatory and Economic Resources ("RER"); and

WHEREAS, staff has recommended that the City Council authorizes the City Manager to enter into an inter-local agreement with RER for the 2016 Adopt-a-Tree event; and

WHEREAS, the \$15,000 are encumbered from fiscal year 2013-14 under the Public Works annual budget under account No.001.80005.500520, if approved, will cover the cost to purchase up to 1,150 trees; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The City Council of the City of Doral hereby authorizes the City Manager to enter into an inter-local agreement with RER, a copy of which is attached as Exhibit "A", for the 2016 City of Doral Adopt-a-Tree event and to expend an amount not to exceed of \$15,000, from the funds encumbered from fiscal year 2013-14, for the purchase of 1,150 trees for the event at Doral Central Park. The Interlocal agreement is hereby approved together with such non-material changes as may be acceptable to the City Manager and approved as to form and legality by the City Attorney. The City Manager is authorized to execute the agreement and expend budgeted funds on behalf of the City.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.

# **EXHIBIT "A"**

## INTERLOCAL AGREEMENT

### **Between the City of Doral and Miami-Dade County**

## for Sponsorship of the Adopt-a-Tree Event in the City of Doral

This Interlocal Agreement by and between the City of Doral, Florida ("the City") and Miami-Dade County, Florida ("the County") is entered into to provide sponsorship of an Adopt-a-Tree event to be held within the City of Doral in September 2016 ("the Event"). For purposes of this Interlocal Agreement ("Agreement"), Miami-Dade County's Department of Regulatory and Economic Resources, Division of Environmental Resources Management shall administer this Interlocal Agreement for and on behalf of the County.

- The City agrees to contribute up to \$15,000 to the County for up to 1,150 trees to be given to the public during the Event. Prior to the Event, County staff shall coordinate with the City on the number and species of trees to stay within the tree budget provided by the City as well as to coordinate the date, time, location, logistics and related specifics.
- II. All other costs for the event shall be paid by the County or other sponsors or both, through the County.
- This Agreement shall commence upon final execution by both parties and shall terminate on September 30, 2016, unless III. otherwise amended as provided for herein.
- Nothing herein shall constitute a waiver of Section 768.28 of the Florida Statutes or shall be construed as impacting or modifying the protections set forth therein.
- The City shall cooperate with the County in the selection of tree species within the parameters of the County's Adopt-a-٧. Tree Program. Trees selected for the event shall be no greater than 3" trunk diameter/caliper in size. All trees shall be grade Florida #1 or better, in accordance with nursery industry guidelines in "Grades and Standards for Nursery Plants."
- The City shall cooperate with the County on selection of the date, location and any decisions necessary for the Event. The County agrees to conduct all required work to obtain the trees for the Event. The County shall deliver the trees to the Event location one day prior to the Event unless other arrangements are mutually agreed upon by the parties.
- VII. The maximum amount the City shall reimburse the County for trees purchased for the Event and for the life of this Agreement is \$15,000.00.
- VIII. Deliverables and Payments.
  - 1. The City agrees to reimburse the County for costs of trees as set forth in this Agreement. The County shall provide to the City an invoice for the actual cost of all trees purchased for the Adopt-a-Tree event in the City.
  - 2. Payment by the City of the invoiced amount to the County shall be made not later than thirty (30) days after receipt of the invoice by the City.
- This Agreement may be modified by amendment through mutual written agreement of both parties. All amendments to IX. this Agreement shall be in writing and signed by both parties, and shall become effective as of the date of the final signatory unless otherwise noted therein.
