

**RESOLUTION No. 21-46**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, AUTHORIZING THE CITY MANAGER TO UTILIZE THE CITY OF MIAMI CONTRACT #516388(21) WITH PUBLIC SAFETY SUPPLY, FOR THE PROVISION OF REPAIRS AND MAINTENANCE IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; RECOGNIZING THAT THIS CONTRACT IS BASED ON THE EXISTING CONTRACT WITH THE CITY OF MIAMI WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V OF THE CITY'S CODE OF ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral Police Department seeks to access the City of Miami Contract No. 516388(21) for the repairs and maintenance of municipal vehicle equipment; and

**WHEREAS**, the Police Department for the last several years purchased and installed its emergency equipment and accessories provided for and equipped by the awarded vendor through the solicitation process. The Police Department respectfully requests to utilize the current City of Miami (Contract #516388(21)) with Public Safety Supply, as an awarded vendor. This contract extends the best prices on the market and allows the Police Department to utilize for repairs and maintenance of municipal vehicle equipment which best meets its needs and functions.

**WHEREAS**, pursuant to Section 2-322 of the City Code, Staff respectfully requests that the City Council authorize the City Manager to negotiate and utilize the City of Miami (Contract #516388(21)) with Public Safety Supply, as an awarded vendor to provide repairs and maintenance of municipal vehicle equipment in an amount not to exceed budgeted funds; and

**WHEREAS**, Staff further requests that Council recognize that this agreement is

based on the existing contract (Exhibit A) with the City of Miami which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The City Council hereby authorizes the City Manager to negotiate and utilize the City of Miami (Contract #516388(21)) with Public Safety Supply, as an awarded vendor to provide repairs and maintenance of municipal vehicle equipment in an amount not to exceed budgeted funds. This purchase is funded from the following account: Repairs and Maintenance Account, #001.60005.500460.

**Section 3. Implementation.** The City Council further recognizes that this agreement is based on the existing agreement (Exhibit A) with the City of Miami contract #516388(21) which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code.

**Section 4. Effective Date.** This Resolution shall become effective immediately upon its adoption.
