

**RESOLUTION No. 18-125**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-233 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE AND RETROFITTING OF SEVEN (7) NEW POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED \$223,217.00, VIA STATE OF FLORIDA CONTRACT #25100000-18-1 AND SHERIFF'S ASSOCIATION CONTRACT FSA17-VEL25.0; APPROVING BUDGET TRANSFERS OF \$184,000.00 FROM ACCOUNT No. 001.60005.500310 (PROFESSIONAL SERVICES), \$30,000.00 FROM ACCOUNT No. 001.60005.500342 (SCHOOL CROSSING GUARD) AND \$45,000.00 FROM ACCOUNT No. 001.60005.500343 (SAFETY RED LIGHT CAMERA) TO ACCOUNT No. 001.6005.500641 (CAPITAL OUTLAY – VEHICLES); AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the "City") Police Department seeks to purchase seven (7) new police vehicles; and

**WHEREAS**, a replacement strategy was developed in order for the economic impact of the new police vehicles purchase not to occur all in one year. When the Police Department was originally established in 2008, some of its current vehicles had been purchased during the same fiscal year. Now that the vehicles are reaching the end of their useful life, we are requesting to replace two (2) 2008 Ford F-250 with two (2) 2018 Ford F-150, three (3) 2013 Chevy Tahoe's with three (3) 2018 Ford Explorers and two (2) 2014 Chevy Tahoe's with two (2) 2018 Chevy Tahoe's.

**WHEREAS**, section 2-322 of the City Code of Ordinances permit the City to purchase good and services via the contracts entered into by other governmental entities provided that such contracts have been competitively reached in a manner that is the same or similar to the procurement requirements of the City Code; and

**WHEREAS**, staff has reviewed the terms of the State of Florida Contract #25100000-18-1 and Sheriff's Association Contract FSA17-Vel25.0 and found the terms advantageous

**WHEREAS**, Staff recommends the City Council approval the purchase purchase and retrofitting of seven (7) new police vehicles not to exceed the total amount of \$223,217.00, via State of Florida Contract #25100000-18-1 and Sheriff's Association Contract FSA17-Vel25.0, and the budget transfer from Professional Services (#001.60005.500310) in the amount of \$184,000.00, School Crossing Guard (#001.60005.500342) in the amount of \$30,000.00 and Safety Red Light Camera (#001.60005.500343) in the amount of \$45,000.00 to Capital Outlay-Vehicles (#001.60005.500641) to accomplish the purchase contemplated herein; and

**WHEREAS**, this purchase is being made from cost savings in two areas of the Police Budget. The first is from \$184,000.00 cost savings associated with funds initially budgeted during fiscal year 2015-2016 from Professional Services to cover designs fees on the Police Substation that came under budget. The second is the cost savings of \$30,000 from the School Crossing Guard budgeted funds which also came under budget, as well as the \$45,000.00 from the Safety Red Light Camera; and

**WHEREAS**, Staff further requests that the City Council approve the Agreement with Garber Fleet Sales, Prestige Ford and Auto Nation Chevrolet for the purchase of seven (7) new police vehicles in the amount of \$203,017.00, retrofitting by Public Safety Supply in the amount of \$20,200.00 for a total not to exceed \$223,217.00.

**NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

**Section 2. Approval.** Pursuant to section 2-322 of the City Code of Ordinances, the purchase of seven (7) new police vehicles from Garber Fleet Sales, State of Florida Contract #25100000-16-1 and Prestige Ford and Auto Nation Chevrolet, Florida Sheriffs Association Bid FSA17-VEL25.0 in the amount of \$203,017.00 and retrofitting of vehicles by Public Safety Supply in the amount of \$20,200.00 for a total not to exceed \$223,217.00, attached hereto as Exhibit "A" and incorporated herein and made a part hereof by this reference, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney, is hereby approved. The budget transfers from Professional Services 001.60005.500310 in the amount of \$184,000.00, School Crossing Guard 001.60005.500342 in the amount of \$30,000.00 and Safety Red Light Camera 001.60005.500343 in the amount of \$45,000.00 to Capital Outlay-Vehicles 001.60005.500641 are hereby approved.

**Section 3. Authorization.** The City Manager is hereby authorized to transfer the funds and to execute the Agreement and expend budgeted funds on the behalf of the City in furtherance hereof.

**Section 4. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.
