

**RESOLUTION No. 22-162**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT REQUESTED BY RYAN D. HERSHBERGER ON BEHALF OF PAR 5 GROUP, TO HOST THE “LIV GOLF INVITATIONAL MIAMI @ TRUMP NATIONAL DORAL” TO BE HELD AT TRUMP NATIONAL DORAL, FLORIDA, 33178 LOCATED AT 4400 NW 87 AVENUE, DORAL, FL 33178 FROM MONDAY, OCTOBER 24, 2022 TO SUNDAY, OCTOBER 30, 2022 FROM 9:00 AM TO 10:00 PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Ryan D. Hershberger (the “Applicant”) seeks approval from the City of Doral for a special event permit to host the “LIV Golf Invitational - Miami @ Trump National Doral” to be held at 4400 NW 87 Avenue; and

**WHEREAS**, staff recommends that the Mayor & City Council approve the proposed special event permit to host the “LIV Golf Invitational – Miami @ Trump National Doral” from Monday, October 24, 2022, to Sunday, October 30, 2022, at Trump National Doral, located at 4400 NW 87 Avenue, Doral, FL 33178, from 9:00 a.m. to 10:00 p.m.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are confirmed, adopted, and incorporated herein and made as part hereof by this reference.

**Section 2. Approval.** The special event permit for the “LIV Golf Invitational - Miami @ Trump National Doral” to be held at Trump National Doral is hereby approved subject to the following conditions:

1. The Applicant shall secure all necessary and required building, electrical, plumbing, or other permits, and shall immediately furnish proof of such permits upon request from the city.
2. Applicant shall be required to have all inspections and approvals prior to the

event date.

3. Sanitary facilities shall be provided by the Applicant and shall be of the type and in a sufficient number as to meet the requirements established by the Building Department.
4. The Applicant is responsible for providing adequate security at the special event. The police department may require the Applicant to provide and pay for security personnel for crowd control and traffic direction purposes. The county fire rescue department may require the Applicant to provide and pay for fire watch personnel.
5. Applicant shall comply with comments made by the City of Doral Police Department and pay all applicable fees no later than 14 days in advance of the event.
6. The Applicant shall provide copy of parking agreement(s) to the Planning and Zoning Department thirty (30) days prior to event start date.
7. The Applicant shall obtain approval from the State of Florida Division of Alcoholic Beverages and Tobacco for the sale of alcoholic beverages prior to event start date. Proof of approval shall be submitted to the Planning and Zoning Department no later than 14 days in advance of the event start date.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption. The motion was seconded by Councilmember Puig-Corve and upon being put to a vote, the vote was as follows:
