RESOLUTION NO. 2007-33

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ENVIROWASTE SERVICES, INC. UNDER THE TERMS AND CONDITIONS OF THE EXISTING CONTRACT WITH ANOTHER PUBLIC AGENCY FOR THE PROVISION OF CATCH BASIN MAINTENANCE SERVICES FOR THE CITY OF DORAL; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to provide its residential and business communities with efficient and effective maintenance of its catch basins; and

WHEREAS, as part of its Stormwater Master Plan, the City of Doral requires a contractor to perform catch basin maintenance; and

WHEREAS, pursuant to Section 12-10 of City of Doral Ordinance #2004-03 "Purchasing and Procurement Procedures," the City may enter into contracts without following competitive bidding processes when another public agency has already followed such procedures; and

WHEREAS, after a thorough review by the Public Works Department of the existing contract between EnviroWaste Services, Inc. and the Village of Pinecrest, Florida, Staff respectfully recommends that the City Council waive the Request for Proposals process and authorize the City Manager to negotiate and enter into an agreement with EnviroWaste Services, Inc. under the terms and conditions of the existing contract with the Village of Pinecrest, Florida to perform catch basin maintenance services for the City of Doral.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA:

Section 1. The City Council of the City of Doral, Florida, hereby waives the Request for Proposals process and authorizes the City Manager to negotiate and enter into an agreement with EnviroWaste Services, Inc. under the terms and conditions of the existing contract with the Village of Pinecrest, Florida to perform catch basin maintenance services for the City of Doral.

Section 2. This Resolution shall become effective upon its passage and adoption by the City Council.
