#### **DESIGN & CONSULTING PROPOSAL**

This project specific Statement of Work ("SOW"), dated **November 4, 2020** (the "Effective Date"), defines the scope of services and deliverables to be performed by Audio Visual Innovations, Inc. (hereinafter "Consultant" or "AVI-SPL") located at 772 South Military Trail, Deerfield Beach FL 33442 for **City of Doral** (hereinafter "Client"), located at 8401 NW 53rd Terrace, Doral, FL 33166. This SOW and its Appendices (collectively, the "Agreement") relates to the **Central Park Project** ("Project") located at **3000 NW 87th Ave, Doral, FL 33172**, and constitute the entire and sole written description of the Services to be provided by AVI-SPL, Inc. and supersedes all prior agreements, representations, or similar documents and any understandings with respect thereto, both written and oral.

#### SCOPE OF SERVICES

AVI-SPL (Consultant) has submitted a proposal to Client to provide the following design & consulting services:

**AUDIO VISUAL:** Design & documentation of audio visual systems and infrastructure, including:

- a. DRAWINGS:
  - o Equipment location layout (floor plans & reflected ceiling plans).
  - Dimensioned elevations.
  - Power, conduit, and related infrastructure architectural guidance related to the AV systems.
  - o Network requirements specific to support of audio visual systems.
- b. SPECIFICATIONS: Detailed list and narrative scope of work for all audio visual systems including equipment make, models and quantities required to achieve desired systems functionality and performance.

<u>IT / TELECOMMUNICATIONS</u>: Design & documentation of IT infrastructure required for the AV systems shall be standards-based, structured and vendor-independent accommodating current and anticipated communication technologies. The resulting infrastructure will offer optimal level of performance in support of, but not limited to, multiple integrated or "IP" enabled systems including voice, data, audio and video network distribution, device automation, audiovisual, etc.



#### DESIGN PHASES AND DELIVERABLES

#### **SCHEMATIC DESIGN (SD)**

During the Schematic Design phase, AVI-SPL will consult with the owner and design team to determine project goals and requirements. AVI-SPL will meet with Owner representatives to develop a systems performance strategy and assist the design and engineering teams in examining the physical impact of suggested technologies.

#### **ACTIVITIES:**

- 1. Organize and conduct up to two (2) in-person "information gathering" meeting with Owner representatives to establish goals and objectives for these systems.
- 2. Identify all impacted areas, rooms and spaces included in the project.
- 3. Establish high-level functional criteria for each.
- 4. Uncover any architectural design criteria may affect AV systems.
- 5. Review Facility Design Standards and any user / functional requirements.
- 6. Discuss existing process and equipment standards that should be incorporated.
- 7. Assist client with site services coordination of services including pathways and demarcation.
- 8. Coordinate Wireless Systems Design requirements received from client IT team.

#### **DELIVERABLES**:

- 1. Prepare a basis of design (BOD) narrative defining the technology system design parameters.
- 2. Preliminary system and technology spaces layouts, as required.



#### **DESIGN DEVELOPMENT (DD)**

Based on the results of SD, AVI-SPL will develop the design with more specifics in form, material, products, etc. Once the Owner has selected a design option that best suits their needs, we will begin the process of refining the design throughout the Design Development phase. These decisions made by the Owner in the DD phase help solidify design strategy in preparation for the construction documents. A number of specific products may be researched and selected. Efforts are focused on the development of detailed infrastructure requirements, and integrating them with the building architecture. AVI-SPL will work closely with the design team to identify critical relationships between audiovisual, voice/data, and line voltage electrical systems.

#### **ACTIVITIES:**

- 1. Up to two (2) in-person coordination meetings where the Owner will have the opportunity to request any modifications desired to achieve the preferred design.
- 2. Design, configuration, and coordination of technology spaces.
- 3. Finalize design scheme, room configuration, and rack and wall elevations for all technology spaces.
- 4. Prepare outline specifications and preliminary drawings (where required) detailing major system components.
- 5. Coordinate fully all technology related requirements with design team including the Architect and MEP Engineer, other project consultants, user groups, furniture supplier, etc.
- 6. Attend Design Development meetings up to (5) meetings via conference call.
- 7. Review and confirm telecommunication services connections/locations MDF/IDF layout and space planning confirmation.

#### **DELIVERABLES:**

- 1. AutoCAD drawing package illustrating:
  - Line and low voltage electrical requirements and conduit requirements.
  - Elevation details for wall-mounted and/or ceiling mounted displays.
  - Equipment rack coordination details for furniture.
- 2. Narrative: Update the BOD narrative provided at the conclusion of the Schematic Design phase to reflect any changes made during Design Development.
- 3. Budget: A detailed budget for selected AV and data cabling systems including line item inventory of materials required.



#### **CONSTRUCTION DOCUMENTS (CD)**

Once the Owner is satisfied with the documents produced during DD, AVI-SPL shall proceed to produces drawings with greater detail, including elevations, mounting details, ventilation requirements, etc. At this time all line and low voltage electrical requirements will be verified and updated as necessary.

#### **ACTIVITIES**:

- 1. Up to two (2) coordination meetings in-person or via conference call to ensure Owner is completely satisfied with specified systems.
- 2. Prepare final working drawings in AutoCAD, calculations and specifications, and in accordance with the project schedule.
- 3. Final coordination of technology system elements with architectural, interior design, structural and civil disciplines, as outlined in the final contract.

#### **DELIVERABLES:**

- 1. Drawing Set: Complete set of audio visual and IT infrastructure drawings suitable for bidding purposes to general contractors, including:
  - Line and low voltage electrical requirements.
  - Conduit requirements.
  - Elevation details for wall-mounted and/or ceiling mounted displays and/or projectors.
  - Equipment rack coordination details for furniture.
- 2. Final technology specifications including:
  - Audio Visual contractor scope of work.
  - A line-item inventory of hardware and software (manufacturers, part numbers and quantities) required to provide the functionality outlined in the systems narrative.
  - Submittal requirements.
  - Warranty and ongoing maintenance / MSA requirements to support installed systems.
  - As-built requirements.
  - Testing procedures.
  - Reporting requirements.
  - A detailed "narrative" outline of capabilities for each area.



#### **GENERAL TERMS & EXCLUSIONS**

- 1. AVI-SPL is a design + build firm. Providing design and consulting services to Client for this Project shall, in no way, disqualify AVI-SPL from bidding on the installation, integration and ongoing support of the audio visual systems as specified in the design documents.
- 2. All technology drawings will be submitted in AutoCAD and/or pdf format.
- 3. Unless otherwise specified in writing, the drawings and other technical inputs provided by AVI-SPL shall be limited in scope to the audio visual portion of the project. AVI-SPL does not assume responsibility for the functions normally ascribed to Project Architect, Engineers or Contractors, including but not limited to:
  - o Electrical design, power loads, phasing and or planning of any kind.
  - Heat load calculations of any kind.
  - Network equipment design and planning of any kind.
  - Telephone system equipment design and planning.
  - o UPS, PDU design, calculation and planning.
  - Building grounding system design, calculations and planning.
  - Server room, IDF HVAC design, calculations and or planning.
  - Structural, weight load calculations of server room, MDF or IDF of any kind.
  - Sprinkler system design, calculations and planning.
  - o Fire suppression system design, calculations and planning.
- 4. It shall be the responsibility of others to verify conformance of the concepts, designs and arrangements represented in the drawings and specifications with all governing laws, codes and restrictions. This shall include, but not be limited to, all structural, fire and building safety, energy conservation and handicapped accessibility requirements.
- 5. Ownership of Documents: Reports, drawings, calculations, specifications, and other materials pertaining to the Project (collectively, "Documents and Reports"), whether in hard copy or machine readable form, whether prepared by AVI-SPL or its agents, are and shall remain the property of Client. All Documents and Reports shall be deemed to be a "work made for hire" within the meaning of the Federal Copyright Act and any similar laws and shall immediately be and become the sale and exclusive property of Client and may be exclusively used and re-used by Client at any time without further compensation to AVI-SPL and without any restrictions.



- 6. Reimbursable Expenses shall be in addition to the Compensation for Design & Consulting Services and shall include actual expenditures made by Consultant, its employees, or its professional consultants in the interest of the Project. All Reimbursable Expenses in excess of \$1,000 shall be approved by the Client in advance and in writing. Reimbursable Expenses include, but are not limited to, the following:
  - Expense for parking, transportation and living when traveling in connection with the Project.
  - Expense for insurance requirements more than AVI-SPL's standard coverage.
- 7. Indemnity. In addition, to the fullest extent permitted by applicable law, Consultant and its agents, partners, employees, and consultants (collectively "Indemnitor") agree to indemnify, protect, defend, and hold harmless Client and its parent, affiliated companies, representatives, agents and employees (collectively the "Indemnified Parties") from and against all claims, damages, losses, liens, causes of action, suits, judgments and expenses, including reasonable attorneys' fees, of any nature, kind, or description (collectively "Claims") of any person or entity whomsoever arising out of, caused by, or resulting from the performance of the services or any part thereof; provided that any such Claims are caused in whole or in part by any breach, default, negligent act or omission or the willful misconduct of any Indemnitor, except to the extent that said Claim is caused in part by the negligence or omission of any Indemnified Parties. This Paragraph shall remain in effect and survive the suspension, abandonment, termination, or completion of this Agreement.
- 8. Excluded: Preparation of "As-Built" documentation (to be included in installation contract).
- 9. Excluded: Preparation of any "Operations Manuals" (to be included in installation contract).



#### CLIENT'S RESPONSIBILITIES

- 1. The Client shall identify a representative authorized to act on the Client's behalf with respect to the Project. The term "Client" means the Client or the Client's authorized representative.
- 2. The Client shall provide full and timely information regarding requirements for, and limitations on, the Project and shall render decisions and approve the Consultant's submittals in a timely manner in order to avoid unreasonable delay in the orderly and sequential progress of the Consultant's services.
- 3. The Client shall establish and periodically update the Client's budget for the Project, including (1) the budget for the Cost of the Work as defined (2) the Client's other costs; and, (3) reasonable contingencies related to these costs. If the Client significantly increases or decreases the Client's budget for the Cost of the Work, the Client shall notify the Consultant. The Client and the Consultant shall thereafter agree to a corresponding change in the Project's scope and quality.
- 4. The Client shall furnish the services of other consultants and contractors in addition to those designated in this Agreement, or authorize the Consultant to furnish them as an Additional Service, when the Consultant requests such services and demonstrates that the scope of the Project reasonably requires them.
- 5. The Client shall provide prompt written notice to the Consultant if the Client becomes aware of any errors, omissions, or inconsistencies in the Consultant's services or in the services or information furnished by the Client.
- 6. Services provided by Client's other consultants or contractors, and the Design-Builder, whether such services are performed directly by them or by their sub consultants or subcontractors, shall be performed by qualified professionals licensed as may be required by applicable law to perform such services in the jurisdiction in which the Project is located. The Client shall require that its other consultants and contractors, and the Design-Builder maintain professional liability insurance as appropriate to the services provided.
- 7. Upon the Consultant's written request, the Client shall furnish surveys to describe physical characteristics, legal limitations, and utility locations for the site of the Project, and a written legal description of the site. The surveys and legal information shall include, as applicable, grades and lines of streets, alleys, pavements and adjoining property and structures; designated wetlands; adjacent drainage; rights-of-way, restrictions, easements, encroachments, zoning, deed restrictions, boundaries and contours of the site; locations, dimensions and necessary data with respect to existing buildings, other improvements and trees; and information concerning available utility services and lines, both public and private, above and below grade, including inverts and depths. All the information on the survey shall be referenced to a Project benchmark.



8. Upon the Consultant's written request, the Client shall furnish tests, inspections and reports required by law, such as structural, mechanical, and chemical tests, tests for air and water pollution, and tests for hazardous materials.

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO SIGN ALL NECESSARY **DOCUMENTS** REQUESTING **MEMBERSHIP** IN THE **INTERLOCAL** PURCHASING SYSTEM (TIPS) COOPERATIVE PROGRAM FOR EQUIPMENT. SUPPLIES AND SERVICES FOR THE CITY OF DEPARTMENTS ON AN AS NEEDED DORAL PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN **EFFECTIVE DATE** 

WHEREAS, the City of Doral (the "City") seeks the access to The Interlocal Purchasing System (TIPS) cooperative program for equipment, supplies and services, for the City of Doral Departments on an as needed basis; and

WHEREAS, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

WHEREAS, the use of cooperative procurement contracts is in the best interest of the City as its usually based on the common requirements of multiple governments. Most cooperative purchasing efforts involved bulk commodities with standard specifications, such as office supplies and furniture, digital copiers and printers, computer hardware, audio visual equipment, electronic defibrillators, hazardous incident response equipment, wireless radios, cell phones, and more complicated requirements, including information technology services, software; and

WHEREAS, staff respectfully recommends the Mayor and City Council adopt The Interlocal Purchasing System (TIPS) cooperative program for Equipment, Supplies and Services in an amount not to exceed budgeted funds, for the period set forth and any approved additional subsequent extensions; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Authorization. The City Council hereby authorizes the City Manager to sign any and all necessary documents requesting membership in TIPS including An Interlocal Agreement. The Interlocal Purchasing System (TIPS) cooperative program for Equipment, Supplies and Services in an amount not to exceed budgeted funds, for the period set forth and any approved additional subsequent extensions.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date</u>. This Resolution shall become effective immediately upon adoption.
