A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO **EXECUTE** Α WORK ORDER WITH AΡ CONSULTING TRANSPORTATION ENGINEERING TO PROVIDE PROFESSIONAL **SERVICES ENGINEERING DESIGN** TO STORMWATER IMPROVEMENTS ALONG NW 89 PLACE BETWEEN NW 25 STREET AND NW 21 STREET FOR A TOTAL NOT TO EXCEED AMOUNT OF \$34,331.49; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF CITY IN **FURTHERANCE** HEREOF; **PROVIDING** IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on March 12, 2014, the 2013 Stormwater Master Plan and the proposed 5-Year Capital Improvement Plan (CIP) was adopted by the City Council via Resolution No. 14-52, approved 5-0; and

WHEREAS, while the 5-Year CIP is being updated, the Public Works Department (PWD) will focus on miscellaneous areas that were not identified in the previous CIP but have been observed by PWD staff to require additional drainage to minimize flooding during significant rain events; and

WHEREAS, in November 2020, the PWD requested a proposal from A&P Consulting Transportation Engineering (APCTE) to provide professional services for the design and permitting of stormwater improvements along NW 89th Place between NW 25th Street and NW 21st Street; and

WHEREAS, the proposed improvements will help address and minimize flooding from significant rain events that have been observed over time at this location; and

WHEREAS, the implementation of stormwater improvements at locations

where flooding is known to occur follows the City's strategic goal of "Quality of Place" and ensures that adequate infrastructure is in place to help prevent flooding; and

WHEREAS, APCTE is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017; and

WHEREAS, City staff recommends that the City Council approve and authorize the City Manager to execute Work Order 13 for APCTE to provide professional services to design stormwater improvements along NW 89th Place between NW 25th Street and NW 21st Street with a not to exceed amount of \$34,331.49; and

WHEREAS, funding for this request is available from Fiscal Year 2020-21 in the Public Works Stormwater Fund – Construction in Progress Account (Line Item-Stormwater Improvements), Account No. 401.80005.500650.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Work Order 13 between the City of Doral and APCTE for the provision to provide professional engineering services to design stormwater improvements along NW 89th Place between NW 25th Street and NW 21st Street, in an amount not to exceed of \$34,331.49, a copy which is attached as Exhibit "A", is hereby approved.

The City of Doral authorizes the firm of A&P Consulting Transportation Engineers for professional Engineering design services for the design of stormwater improvements along NW 89th Place between NW 25th Street and NW 21st Street. Where A&P Consulting Transportation Engineers is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017 through Resolution 17-202. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between A&P Consulting Transportation Engineers and the City of Doral dated January 30, 2018, and the attached Proposal dated November 3, 2020 and submitted by your firm for the above referenced project.

SCOPE OF SERVICES AND SCEHDULE:

The scope of the project will be as described in the attached proposal from A&P Consulting Transportation Engineers dated November 3, 2020 to design stormwater improvements along NW 89th Place (NW 25th St-NW 21st St). The schedule requires the scoped of work to be completed within 9 weeks of Notice to Proceed. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and material basis not to exceed the amount of \$34,331.49.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated January 30, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply. Work Order is not binding until the City of Doral agrees and approves this Work Order.
