

RESOLUTION No. 16-176

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY CLERK TO PUBLISH LEGAL ADVERTISEMENTS IN THE DAILY BUSINESS REVIEW, THE MIAMI HERALD AND ANY OTHER LOCAL NEWSPAPER AS REQUIRED BY FLORIDA STATE STATUTES AND SECTION 2-71 OF THE CITY OF DORAL CODE OF ORDINANCES, OR OTHER ADVERTISEMENTS AS MAY SEEM FIT; IN THE AMOUNT BUDGETED FOR FY 15-16; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Clerk is tasked with placing any and all legal advertisements as required by the laws of the State of Florida and the Section 2-71 of the Doral Code; and

WHEREAS, during FY 2015-2016, the City Clerk's Office had an approved budget in the amount of \$136,000.00 for legal advertisements to be found under line item 001.12005.500491, plus \$70,000.00 which was transferred from other account(s) within the City Clerk's Office Budget and approved by Council via Resolution No. 16-158 during the Budget Adjustments to the General Fund; and

WHEREAS, the City Clerk utilizes the services of the Daily Business Review and the Miami Herald for legal advertisements and may from time-to-time find it necessary to utilize the services of other local newspapers/venues to disseminate information about the City; and

WHEREAS, the City Clerk has recommended that the City Council authorize the publishing of legal advertisements in the Daily Business Review and The Miami Herald as well as any other local newspaper as required by State Statute and section 2-71 of the City of Doral Code in the amount budgeted for the remainder of FY 15-16.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Authorization. The City Council hereby authorizes the City Clerk to publish legal advertisements in the Miami Herald and the Daily Business Review as well as any other local newspaper as required by State Statutes and Section 2-71 of the Doral Code or other advertisements as may seem fit for the remainder of FY 15-16.

Section 3. Implementation. The City Clerk and the City Manager are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Councilmember Ruiz and upon being put to a vote, the vote was as follows:
