WHEREAS, Five (5) firms attended the pre-bid meeting which was held on September 3, 2021. One (1) submittal was received on September 17, 2021 with the firm and submittal meeting the required criteria; and

WHEREAS, upon review of bids received, staff determined that CDI LLC dba

Christmas Designers was the lowest most responsive and responsible bidder; and

WHEREAS, The City Manager's office respectfully requests approval from Mayor and Members of the City Council to award ITB# 2021-16 "Purchase of Holiday Tree" to CDI LLC dba Christmas Designers and authorize the City Manager to enter into an agreement with CDI LLC for the provision of purchasing a new holiday tree in an amount not to exceed \$38,465.00 from available funds carried forward from Fiscal Year 2021, in account 001.90005.500640.
