## **RESOLUTION NO. 11-33**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY CLERK TO PUBLISH ADVERTISEMENTS IN THE MIAMI HERALD, THE DAILY BUSINESS REVIEW AND ANY OTHER LOCAL NEWSPAPER AS REQUIRED BY FLORIDA STATE STATUTES AND CITY OF DORAL ORDINANCE #2009-09 OR OTHER ADVERTISEMENTS AS MAY SEEM FIT IN AN AMOUNT NOT TO EXCEED \$150,000.00 IN THE AGGREGATE FOR FY 10-11; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Clerk is tasked with making any and all advertisements as required by the State of Florida and the City of Doral; and

WHEREAS, during FY 2010-2011, the City Clerk's Office has an approved budget of \$150,000.00 for legal advertisement to be found under line item 001.12005.500491; and

WHEREAS, the City Clerk utilizes the services of the Miami Herald and the Daily Business Review for advertisements and may from time-to-time find it necessary to utilize the services of other local newspapers / venues to disseminate information about the City; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Clerk to publish advertisements in the Miami Herald, the Daily Business Review and any other local newspaper as required by Florida State Statutes and City of Doral Ordinance #2009-09 or other advertisements as may seem fit in an amount not to exceed \$150,000.00 in the aggregate for FY 2010-2011.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

**Section 1.** The foregoing recitals are hereby incorporated by reference.

Section 2. The City Council of the City of Doral hereby authorizes the City Clerk to publish advertisements in the Miami Herald, the Daily Business Review and any other local newspaper as required by Florida State Statutes and City of Doral Ordinance #2009-09, or other advertisements as may seem fit, in an amount not to exceed \$150,000.00 in the aggregate for FY 2010-2011.

Section 3. This Resolution shall become effective immediately upon adoption.
