## **RESOLUTION No. 15-193**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXTEND THE EXISTING AGREEMENT WITH DORAL VOLLEYBALL ACADEMY FOR THE PROVISION OF RECREATIONAL YOUTH SAND VOLLEYBALL PROGRAM MANAGEMENT FOR THE CITY OF DORAL PARKS AND RECREATION DEPARTMENT FOR A PERIOD OF THREE (3) MONTHS THROUGH DECEMBER 2015; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") has an existing agreement with Doral Volleyball Academy for recreational youth sand volleyball program management; and

WHEREAS, staff advertised RFP #2015-31 "Recreational Youth Sand Volleyball Program Management" on September 21, 2015 for the provision of recreational youth sand volleyball program management; and

WHEREAS, Staff respectfully recommends that the City Council authorize the City Manager to extend the agreement with Doral Volleyball Academy for the provision of recreational youth sand volleyball program management for the City of Doral Parks and Recreation Department for a period of three (3) months through December 2015 while submittals for RFP #2015-31 "Recreational Youth Sand Volleyball Program Management" are received, scored, and recommended to Council.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval of Extension.</u> The City Council hereby authorizes the City Manager to extend the agreement with Doral Volleyball Academy for the provision of

recreational youth sand volleyball program management for the City of Doral Parks and Recreation Department for a period of three (3) months through December 2015.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.
