

## RESOLUTION NO. 05-60

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA; ESTABLISHING A PROPOSED MILLAGE RATE OF 2.447 TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2005-2006, ESTABLISHING THE CURRENT YEAR ROLLED-BACK RATE TO BE 2.1253, AND ESTABLISHING THE FIRST AND THE SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CLERK AND MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE OF THE STATE OF FLORIDA; ESTABLISHING THE TIME AND LOCATION OF THE FIRST AND SECOND PUBLIC HEARINGS; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, on July 1, 2005 the Honorable Joel Robbins, Property Appraiser of Miami-Dade County, Florida, served upon The City of Doral, A "Certification of Taxable Value" certifying to The City of Doral its 2005 taxable value: and

WHEREAS, the provisions of Florida Statutes Section 200.065 require that within thirty five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a first public hearing will be held to consider the proposed millage and tentative budget; and

WHEREAS, The City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

WHEREAS, The City Council has reviewed the figures supplied by the Property Appraiser of Miami-Dade County and that being otherwise fully advised in the premises;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL  
OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:**

**Section 1.** That the proposed millage for the first public hearing is hereby declared to be 2.447 mills which is \$2.447 per \$1,000.00 of assessed property within the City of Doral.

**Section 2.** That the City Council further confirms the current year rolled-back rate, computed pursuant to section 200.065 F.S., is \$2.1253 per \$1,000.00

**Section 3.** That the date, time and place of the first and second public hearings is hereby set by The City Council as follows:

**Section 4.** That the City Clerk and City Manager are directed to attach the original Certification of Taxable Value to certified copy of this resolution and serve the same upon the Honorable Joel Robbins, Property Appraiser of Miami-Dade County on or before August 5, 2005.

**Section 5.** This resolution shall be effective immediately upon its adoption.


