

RESOLUTION No. 13-49

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL FLORIDA, PURSUANT TO SEC. 2-322 OF THE CITY CODE, ADOPTING THE EXISTING AGREEMENT BETWEEN BROWARD COUNTY, FLORIDA AND SCIENCE APPLICATIONS INTERNATIONAL CORPORATION FOR THE PROVISION OF DEBRIS MONITORING SERVICES THROUGH DECEMBER 1, 2013 WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V OF THE CITY CODE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Resolution No. 08-61 authorized an agreement with Beck Disaster Recovery, Inc. (Beck) for the provision of disaster debris monitoring and emergency management related services; and

WHEREAS, Resolution No. 10-75, authorized the adoption of the terms of the agreement between Beck and Broward County, Florida; and

WHEREAS, Beck merged with Science Applications International Corporation (SAIC) and a new cost list with a five percent (5%) lower cost than the original Broward County agreement was adopted by the City through Resolution No. 12-26; and

WHEREAS, although said agreement was set to expire on June 1, 2013, Broward County extended the agreement with SAIC for six (6) months through December 1, 2013; and

WHEREAS, in order to avoid a gap for debris monitoring services in the middle of hurricane season, Staff respectfully requests that the City Council, pursuant to Sec. 2-322 of the City Code, adopt the existing agreement between Broward County, Florida and SAIC for the provision of debris monitoring services through December 1, 2013 which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council, pursuant to Sec. 2-322 of the City Code, hereby adopts the existing agreement between Broward County, Florida and SAIC for the provision of debris monitoring services through December 1, 2013 which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code.

Section 2. This Resolution shall take effect immediately upon adoption.

The foregoing resolution was offered by Councilwoman Rodriguez who moved its adoption. The motion was seconded by Vice Mayor Rodriguez Aguilera and upon being put to a vote, the vote was as follows:
