

**RESOLUTION No. 20-03**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPECIAL EVENT PERMIT FOR MIA BEER CO., TO HOST THE “MIA BREWERY ANNIVERSARY PARTY” AT MIA BEER CO. PREMISES AT 10400 NW 33 ST, UNIT 150, DORAL, FL 33172 ON SATURDAY, FEBRUARY 29, 2020, FROM 3:00PM TO 10:00PM; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, MIA Beer Co. (“Applicant”) seeks approval from the City of Doral for a Special Event Permit; and

**WHEREAS**, staff recommends Council to approve the proposed Special Event Permit to host the “MIA Brewery Anniversary Party” on Saturday, February 29, 2020, located at MIA Beer Co. premises, 10400 NW 33 Street, Unit 150, Doral, FL 33172.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein.

**Section 2. Approval.** The Special Event Permit for the “MIA Brewery Anniversary Party” is hereby approved subject to the following conditions:

1. Applicant shall comply with the comments made by the City of Doral Police Department.
2. Applicant shall comply with all Building Permits and inspections required by the Building Department prior to the event start date.
3. Applicant is responsible to pay all outstanding City fees prior to the issuance of the Special Event Permit.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon adoption.
