

**RESOLUTION No. 21-04**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A WORK ORDER WITH PEVIDA HIGHWAY DESIGNERS TO PROVIDE PROFESSIONAL SERVICES TO SUPPORT THE CITY DURING THE PROCUREMENT PHASE OF THE PEDESTRIAN BRIDGE PARK BOND PROJECT, FOR A TOTAL NOT TO EXCEED AMOUNT OF \$24,892.00; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Public Works Department (PWD) presented conceptual designs to City Council at the June 22, 2016 Zoning Council meeting where the preferred option currently under design was selected; and

**WHEREAS**, in February 2017, the PWD applied for grant funding through the Florida Department of Transportation (FDOT) Transportation Alternative Program (TAP) Grant; and

**WHEREAS**, on June 22, 2017 the City was notified we were awarded \$1 million dollars towards the project and the funds were allocated in FDOT's FY 2023; and

**WHEREAS**, the City requested FDOT to bring the funding forward in order to procure the services of a design-build team and begin construction in FY 2020-21; and

**WHEREAS**, at the January 17, 2019 Parks Bond Workshop, City Council made suggestions that would alter the current approved concept; and

**WHEREAS**, the project was advertised on December 18, 2020; and

**WHEREAS**, Pevida Highway Designers, is a prequalified provider of professional engineering services selected via RFQ 2017-21 and in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017 through Resolution 17-202; and

**WHEREAS**, City staff respectfully requests that the Mayor and City Council members approve Work Order No. 10 for Pevida Highway Designer, a copy of which is attached hereto as Exhibit "A", for the provision of professional engineering services to provide support to the City during the procurement phase of the Pedestrian Bridge project, on a time and material basis in an amount not to exceed \$24,892.00, and

**WHEREAS**, funds for these services will be allocated from the Park Bond Fund in Fiscal Year 2020-21 in account number 303.9000572.500650.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:**

**Section 1. Approval.** Work Order 10 between the City of Doral and Pevida Highway Designers for the provision to provide professional engineering services to provide support to the City during the procurement phase of the Pedestrian Bridge project, on a time and material basis in an amount not to exceed \$24,892.00, a copy which is attached as Exhibit "A", is hereby approved.

**Section 2. Authorization.** The City Manager is authorized to execute the Work Order and expend budgeted funds on behalf of the City in furtherance hereof.

**Section 3. Implementation.** The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Mariaca who moved its adoption.

The City of Doral authorizes the firm of Pevida Highway Designers, LLC to provide professional engineering services for the geotechnical services for Doral Central Park. Where Pevida Highway Designers, LLC is a prequalified provider of professional engineering services selected in accordance with Consultant Competitive Negotiation Act (CCNA) requirements and approved by the City Council in November 2017 through Resolution 17-202. The work should be performed in accordance with the contract provisions contained in the Continuing Professional Services Agreement between Pevida Highway Designers, LLC and the City of Doral dated February 16, 2018, and the attached Proposal dated December 18, 2021 submitted by your firm for the above referenced project.

**SCOPE OF SERVICES AND SCHEDULE:**

The scope of the project will be as described in the attached proposal from PHD dated December 18, 2021. The scope includes the support of City staff during the procurement phase of the Pedestrian Bridge project. The schedule requires the work to be performed as the procurement process is on-going for the project. All limitations of time set forth in this Work Order are of the essence. The performance of services associated with this Work Order will be executed on a time and materials basis with a not to exceed amount of \$24,892.00.

You are required by the Continuing Service Agreement to begin work subsequent to the execution of this Work Order, or as directed otherwise. If you fail to begin work subsequent to the execution of this Work Order, the City of Doral will be entitled to disqualify the Proposal and revoke the award.

Work Order incorporates the terms and conditions set forth in the Continuing Services Agreement dated February 16, 2018 between the parties as though fully set forth herein. In the event that any terms or conditions of this Work Order conflict with the Continuing Services Agreement, the provisions of this specific Work Order shall prevail and apply.

This Work Order is not binding until the City of Doral agrees and approves this Work Order.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement on the day and date first above written, in three (3) counterparts, each of which shall, without proof or accounting for the other counterpart be deemed an original Contract.
