

**RESOLUTION No. 16-117**

**A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING A BUDGET TRANSFER OF \$289,000.00 FROM THE PUBLIC WORKS VEHICLES ACCOUNT #001.80005.500522 TO BE DISTRIBUTED INTO THE CITY ATTORNEY LITIGATION CONTINGENCY ACCOUNT, #001.30005.500316; AND A \$120,000.00 TRANSFER WITHIN THE CITY ATTORNEY PROFESSIONAL SERVICES ACCOUNTS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the City of Doral (the “City”) has had an increase in litigation costs;  
and

**WHEREAS**, the City has realized savings in the operating supplies – fuel account, as a result of lower than expected fuel prices, that are available for reallocation; and

**WHEREAS**, the City Attorney wishes to transfer \$289,000.00 from the Public Works Operating Supplies Vehicle Account to meet the litigation cost increase and transfer \$120,000.00 within the City Attorney Professional Services accounts; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2. Approval.** The transfer of \$289,000.00 from the Public Works Operating Supplies Vehicle Account, #001.80005.500522 to the City Attorney Litigation Contingency Account, #001.30005.500316 and the transfer of \$120,000.00 from the City Attorney Professional Services “General” Account 001.30005.500311 to the City Attorney Professional Services “Other” Account 001.30005.500312 in order to provide funds for the increase in litigation costs for the City Attorney and to adjust funds within the

department is hereby approved.


**Section 3. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.


