

RESOLUTION No. 20-96

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A SPONSORSHIP FOR DIVIETO RISTORANTE’S “FEED THE FRONT LINES MIAMI” EVENT IN THE AMOUNT OF \$5,000.00; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Divieto Ristorante (“Applicant”) is requesting Sponsorship from the City of Doral (“the City”) to provide financial support for the “Feed the Front Lines Miami (“Event”)” where food is distributed to first responders; and

WHEREAS, the COVID-19 Pandemic has shut down many of our local restaurants while healthcare professionals continue to work on the frontlines to keep us safe; and

WHEREAS, Feed the Frontlines Miami supports Miami restaurants by creating opportunities for their employees to prepare and distribute free meals for hospital workers around the City; and

WHEREAS, since March 20, 2020, Divieto Ristorante served more than 2,600 meals to Miami-Dade Fire Department, Miami-Dade Police Department and urgent care givers; and

WHEREAS, in consideration of Feed the Front Lines Miami sponsorship by the City of Doral, Divieto Ristorante will be supporting the participation of City of Doral’s Police in one of the food handouts to essential first responders; and

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Approval. The Mayor and City Council hereby approve Divieto

Ristorante (“Applicant”) in the amount of \$5,000 to sponsor “Feed the Front Lines Miami (“Event”)”.

Section 3. Effective Date. This Resolution shall take effect immediately upon adoption.
